

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held February 15, 1983 at 3:00 P.M. in Council Chambers with all members present.

Members of the press present: Dick Mangrum - WSNW Radio, Glen Gannaway - Seneca Journal & Dave Givens - Greenville News.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Dr. Earle.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 to adopt the minutes of the February 1, 1983 meeting as printed.

Mr. Richard Lay, Executive Director of the Anderson-Oconee Council on Aging presented to Council some of the services provided by that agency. In his presentation he stated that those sixty-five years of age and over had increased 91% from 1970 to 1980.

Council on Aging provides social services, congregate dining, home delivered meals (Oconee only), day care, senior employment and ombudsman.

They also provide special activities such as picnics, sing alongs, encampments, outings, Thanksgiving & Christmas meals. They furnished transportation for the elderly to the World Fair & State Fair. They dispensed cheese to the needy and energy assistance. The needs of the elderly in Anderson & Oconee Counties is expected to increase in 1983-84 and they are requesting \$18,000 in the Oconee Budget.

Mr. Doyle Kay, Executive Director of the Anderson-Oconee Alcohol & Drug Abuse Commission presented the attached annual report to Council.

Mr. Luther Cunningham of the Corps of Engineers requested that Oconee County enter into agreements for maintenance of the following boat ramps located in Oconee County: Barton's Mill, South Union, Lakeshore, Timberlake, Seneca Creek, Holder's Landing & Pt. Bass. The county will be responsible for liability insurance and removal of garbage.

Mr. Williams made this into the form of a motion, seconded by Dr. Earle, approved 5 - 0.

Page 2 - February 15, 1983

Mr. Harper made a motion, seconded by Dr. Earle, approved 5 - 0 to accept the bid of Wilson's Masonary at \$2,456.40 to reroof the Rock Building.


Dr. Earle made a motion, seconded by Mr. Williams, approved 5 - 0 to accept the attached job descriptions for the Children's Home.

Mr. Williams made a motion, seconded by Dr. Earle, approved 5 - 0 that \$532.10 be taken from contingency and placed in the Treasurer's budget, line item 20 33 00 1, postage for March tax notices.

Mr. Williams made a motion, seconded by Mr. Brandt, approved 5 - 0 that the attached transfers (money already in budget) be approved and at the same time approved purchase of a used 80D North Western Shovel from Clement Brothers for \$67,500 (this involves no additional funding).

Mr. Brandt made a motion, seconded by Mr. Butts, approved 5 - 0 that Ms. Melinda Maksymowicz be appointed to the Arts & Historical Commission to replace Ms. Lucy Gandy. The term commences immediately and expires December 31, 1985.
