

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, May 15, 1990 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

Members of the press notified (by mail): Seneca Journal, Keowee Courier, Westminster News, Anderson Independent, Greenville News, WGOG Radio, WSNW Radio, WBES Radio, WZLI/WLET Radio, WYFF TV & WLOS TV.

All other persons who have asked to be notified of meetings were also notified by mail.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Stone.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that the minutes of the May 1, 1990 meeting be adopted as printed.

Dr. Earle made a motion, seconded by Mr. Strickland, approved 5 - 0 that Resolution 90-8, "A Resolution Supporting The South Carolina Appalachian Council of Governments' Project to Provide Planning Services to The Appalachian Region" be adopted on first and final reading.

Dr. Earle made a motion, seconded by Mr. Strickland, approved 5 - 0 that the attached Intergovernmental Agreement for a Community Development Block Grant Project, on behalf of the South Carolina Appalachian Council of Governments be adopted.

At the request of Mr. Robert Gaillard, Planning Director, Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that he be granted permission to apply for ARC & HUD Grants for a sewer line to the Cryovac plant and/or a CDBG Grant for a rail spur for the plant.

Mr. Robert Winchester, Sewer Commission Director, and Mr. Johnny McLellan, Finance Director, presented the attached proposed 1990-91 Sewer Commission Budget to Council. After discussion, Mr. Dyar made a motion, seconded by Mr. Harper, approved 5 - 0 the budget be adopted.

Dr. Earle made a motion, seconded by Mr. Harper, approved 5 - 0 that the purchase order for the automation system at the Library be issued. The private donation of \$13,500 has not yet been received, however, we are in receipt of the attached letter stating the funds will be available July 10, 1990.

Four thousand dollars from the sale of the old Library will also go toward this purchase.

Mr. Dyar made a motion, seconded by Mr. Strickland, approved 5 - 0 that the attached rate schedule for reserving the recreation buildings at the county parks be adopted.

Mr. Strickland made a motion, seconded by Mr. Stone, approved 5 - 0 that the tabled motion regarding a county wide picnic made May 1, 1990 be taken from the table.

After discussion, Mr. Strickland withdrew his motion regarding the picnic, this was approved 4 - 0 (Dr. Earle out of the room).

Mr. Stone made a motion, seconded by Mr. Strickland, approved 4 - 0 (Dr. Earle out of room) to give Recovery Mountain a load of gravel.

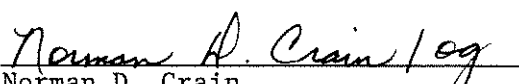

This amount was originally paid to the owner when the lot was sold for tax purposes in 1987 and it should have gone to Chickasaw Point as the lot had a judgement against it.
