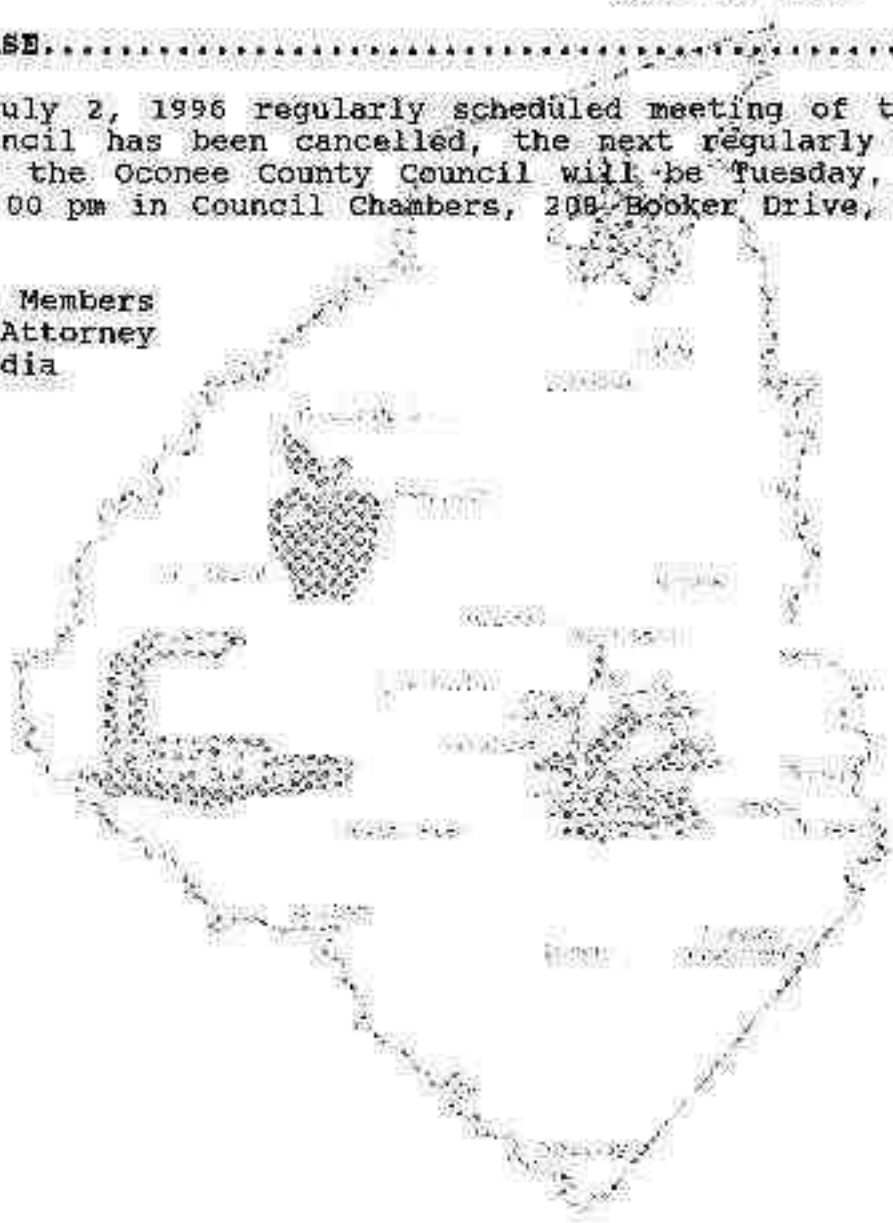

The Oconee County Sheriff's Department is requesting that two (2) police package sedans be purchased to provide patrol vehicles for two additional Deputy positions approved in the 1996-97 Budget Ordinance. This purchase would require that the county bid process be waived since the per unit vehicle cost exceeds the 1996 state contract price. Otherwise, we will not receive any new vehicles until at least February 1997.

We received vehicles in February 1996 at a per unit cost of \$18,152.30. The cost (base price, options and tax) for each proposed vehicle purchase is \$19,219.00. This is an increase of \$1,066.70 per vehicle over the 1996 state contract price. However, the 1997 estimate for police package vehicles is a base price of \$19,800.00.

Last July, the Oconee County Council authorized the purchase of three police vehicles (two marked and one unmarked) under similar circumstances.

These vehicles are available from Vic Bailey Ford, which is the provider for state contract vehicles. Only six of these vehicles were left as of 7/3/96. We have \$19,690.00 budgeted for each new vehicle this year. Our total request is for \$38,438.00.
