**Resolution 2006-08:**

Mr. Moore made a motion, seconded by Mr. Crumpton, approved 4 – 0 that Resolution 2006-08, “A RESOLUTION REQUESTING THAT THE OCONEE COUNTY PLANNING COMMISSION STUDY AND MAKE RECOMMENDATIONS TO COUNTY COUNCIL CONCERNING ORDINANCES AND REGULATIONS NECESSARY TO PROTECT LAKES JOCASSEE, KEOWEE AND HARTWELL” be adopted on first and final reading.

**Ordinance 2006-04:**

Mr. Moore made a motion, seconded by Mr. Rinehart, approved 4 – 0 that Ordinance 2006-04, “AN AMENDMENT TO LOAN AGREEMENT RELATING TO \$35,000,000 OCONEE COUNTY, SOUTH CAROLINA POLLUTION CONTROL REVENUE REFUNDING BONDS (DUKE ENERGY CORPORATION, SERIES 1999A AND 1999B) (THE “BONDS”) TO PROVIDE FOR GUARANTEE THEREOF” be adopted on first reading.

**Ordinance 2006-05:**

Mr. Crumpton made a motion, seconded by Mr. Rinehart, approved 4 – 0 that Ordinance 2006-05, “AN AMENDMENT TO LOAN AGREEMENT RELATING TO \$77,000,000 OCONEE COUNTY, SOUTH CAROLINA POLLUTION CONTROL FACILITIES REVENUE REFUNDING BONDS, SERIES 1993 (DUKE POWER COMPANY PROJECT) (THE “BONDS”) TO PROVIDE FOR GUARANTEE THEREOF” be adopted on first reading.
