

**OCONEE COUNTY COUNCIL  
ORDINANCE NO 2007-19  
AN ORDINANCE ESTABLISHING A HOME DETENTION PROGRAM**

WHEREAS, the Home Detention Act of 1990 allows for Counties to establish a home detention program as an alternative to confinement in the County detention facility; and

WHEREAS, a Home Detention program will reduce the cost to the County for confining low risk, non-violent adults and juveniles; and

WHEREAS, a Home Detention program will increase the space within the County detention facility for high risk adult offenders; and

WHEREAS, a Home Detention program would allow participants in the program to engage in gainful employment,

NOW, THEREFORE, BE IT ORDAINED BY COUNCIL, DULY ASSEMBLED AND VOTING, WITH QUORUM PRESENT, the following:

I. A Home Detention program is hereby established in Oconee County as an alternative in the Oconee County Detention Center in accordance with the Home Detention Act of 1990 [S.C. Code Section 24-13-1510, et. Seq.]

II. In accordance with S. C Code Section 24-13-1530, an electronic and non-electronic home detention program may be used by any Court in Oconee County having criminal or juvenile jurisdiction to sentence an individual to incarceration and whose sentences do not place them in the custody of the State Department of Corrections. The home detention program established by this Ordinance will be an alternative for low risk, non-violent adults and juvenile offenders who are selected by the Court and who comply with the regulations and program guidelines adopted by Oconee County in accordance with this Ordinance. This program may also apply to pretrial or pre-adjudicatory detention, community corrections [diversion] and work release.

III. The home detention program hereby established in Oconee County shall comply with all applicable state and local laws and regulations, including but not limited to, S. C. Code Section 24-13-1510, et. Seq., as amended and minimum standards for local detention facilities in South Carolina. The Oconee County Sheriff, as the detention facility administrator, or his designee, shall establish guidelines, policies, procedures, rules and regulations for the Home Detention program. The Sheriff or his designee shall be responsible for implementation and administration of the program.

Request for Oconee County PRT to participate in the 2008 Atlanta Boat Show as an exhibitor

**BACKGROUND OR HISTORY:**

The PRT Commission requests the use of up to \$6,000 from the 75% fund of the local accommodations tax for all costs associated with having an Oconee County booth at the upcoming Atlanta Boat Show. These funds will cover booth expenses, as well as travel, lodging and per diem for staff and several commission members to work the 5 day show from January 9-13, 2008. This show averages 50,000 in attendance annually and provides an opportunity to showcase Oconee County and the surrounding lakes to the Atlanta region. Using funds to promote Oconee County in a way to generate publicity is an acceptable expenditure of local accommodations tax funds.

**SPECIAL CONSIDERATIONS OR CONCERNS:**

All funds used are to come from the 75% Local Accommodations Tax fund. The existing balance of the 75% fund is \$168,745.19



**BACKGROUND OR HISTORY:**

State ATAX funds are received quarterly and 65% of those funds are Tourism Related funds that are to be disbursed as recommended by the ATAX committee and approved by County Council.

**SPECIAL CONSIDERATIONS OR CONCERNS:**

Original grant requests was \$2,770.00. The ATAX Committee deemed that \$250.00 of the requested funds were not fundable, therefore the amount recommended for approval is \$2,520.00.

# Capital Sales Tax Commission Info

## SECTION 4-10-320. Commission creation; composition. [SC ST SEC 4-10-320]

(A) The governing body of any county is authorized to create a commission subject to the provisions of this section. The commission consists of six members, all of whom must be residents of the county; appointed as follows:

(1) The governing body of the county must appoint three members of the commission.

(2) The municipalities in the county must appoint three members, who must be residents of incorporated municipalities within the county, and who are selected according to the following mechanism:

(a) The total population of all incorporated municipalities within the county, as determined by the most recent United States census, must be divided by three, the result being an apportionate average.

(b) The respective population of each municipality in the county must be divided by the apportionate average to determine an appointive index.

(c) Each municipality in the county appoints a number of members to the commission equal to the whole number indicated by their appointive index. However, no single municipality may appoint more than two members to the commission, unless there is only one municipality in the county, and in such case the municipality is entitled to three appointments to the commission.

(d) When less than three members are selected to the commission in accordance with the prescribed appointive index method, the remaining member or members must be selected in a joint meeting of the commission appointees of the municipalities in the county. The member or members must be chosen from among the residents of the municipalities in the county that before this time have not provided a representative for the commission.

(e) In the event no municipality is entitled to appoint a member to the commission pursuant to the formula in subitem (c) of this subsection, the municipality with the highest appointive index must be deemed to have an appointive index of one.

(B) When the governing body of any county creates a commission, it must be created in accordance with the procedures specified in subsection (A) and only upon the request of the governing body of the county. If within the thirty-day period following the adoption of a resolution to create the commission, one or more of the municipalities fails or refuses to appoint their proportionate number of members to the commission, the county governing body must appoint an additional number of members equal to the number that any such municipality is entitled to appoint. A vacancy on the commission must be filled in the manner of the original appointment.

(C) The commission created pursuant to this section must consider proposals for funding capital projects within the county area. The commission then formulates the referendum question that is to appear on the ballot pursuant to Section 4-10-330(D).



**AIRCRAFT HANGAR LEASE**

THIS AGREEMENT MADE AND ENTERED into this day of \_\_\_\_\_, by and between OCONEE COUNTY, SOUTH CAROLINA, hereinafter referred to as "THE COUNTY" and \_\_\_\_\_, hereinafter referred to as "THE LESSEE".

The County hereby leases to the Lessee and Lessee leases from the County "T" Hangar No. \_\_\_\_\_ for a period of one (1) year beginning on the \_\_\_\_\_ day of \_\_\_\_\_ at a monthly rental rate of \_\_\_\_\_ per month.

The County and Lessee Agree as follows:

The hangar is to be used solely for the storage of the aircraft owned by the lessee and No other aircraft may be stored in the hangar unless otherwise permitted in accordance with this lease. Hangars are not to be used for any other purpose other than the storage of an aircraft. Storage of items not directly related to operation of the stored aircraft is strictly prohibited, constitutes breach of agreement and may result in eviction from the hangar. (\_\_\_\_\_) initials.

1. Lessee will pay the rental payments no later than the first day of the lease and thereafter on the first day of each month. In the event this lease is extended at the end of the term, payments may be made on a monthly basis as provided herein. If payment is made later than the 10<sup>th</sup> day of the month, a late penalty in the amount of 10% will be assessed.
2. Lessee shall not perform aircraft maintenance in the leased space except Preventive Maintenance as defined in FAR 43 Appendix A Section C, and hereby made a part of this lease and referred to as "Attachment A". Such maintenance shall only be performed by the aircraft owner or their duly authorized pilot who is insured by said owner and is listed on the insurance policy of said aircraft. Such preventive maintenance shall be confined to an individual's personal airplane, and no other, and must be accomplished in accordance with FAA regulations, as well as all applicable State, Federal and local laws or regulations.
3. The Airport Director and other Designees of Oconee County shall have the right to enter and inspect the leased premises at any reasonable time without notice to the Lessee.
4. Lessee shall not sublet the leased premises without advance written permission of the Airport Director (\_\_\_\_\_) initials. Lessee also hereby agrees to comply with and abide by all Federal, State, and local laws / ordinances and regulations as rules applicable, including any airport rules set by the Airport Director. Lessee understands the Oconee County Regional Airport is obligated and covenanted by certain FAA AIP grant assurances.
5. Lessee will hold Oconee County, the Oconee County Aeronautics Advisory Commission, the Oconee County Council and the County's employees and agents harmless and will indemnify the same or any injury, claim, demand, suit, or demand by any person for any account of injury or damage sustained by persons or property on

account of any activity of the Lessee or on account of the use of the space by Lessee in any manner whatsoever.

6. Lessee shall be the majority owner of any aircraft stored in any hangar under this lease. In order for the Lessee to qualify as an owner of the aircraft, Lessee shall be specifically listed as an owner on the official FAA registration certificate of the aircraft and shall be specifically listed as an owner and named insured on all insurance policies on said aircraft. If Lessee's aircraft is owned by a corporation, limited liability corporation (LLC), or partnership Lessee shall be listed as the corporation, LLC, or partnership and the lease shall be signed by a duly authorized officer of the corporation or LLC, or partnership.
7. The County shall not be liable for any loss, injury, death or damage to persons or property which at any time may be suffered or sustained by the Lessee or by any person may at any time be using or occupying or visiting the demised premises or be in, on or about the same, whether such loss, injury, death or damage shall be caused by, or in any way result from, or arise out of any act, omission, or negligence of the Lessee or of any occupant, visitor or user of any portion of the premises, or that shall result from or be caused by any other matter or thing, whether of the same kind as or of a different kind than the matters or things above set forth, and Lessee shall indemnify the County against all claims, liability, loss, or damage whatsoever on account of any such loss, injury, death or damage. Lessee hereby waives all claims against the County for damages or injury to the aircraft or property of the Lessee stored in or upon the leased premises or from any cause arising at any time during the term hereof, to include damage resulting from wind, collapse of building, lightning, fire, vandalism, war, theft, or the negligence of any person. Lessee agrees to obtain/maintain Airport Premises Liability Insurance and Automobile Liability Insurance for the entire duration of this lease agreement.  
  
The Lessee acknowledges that from time to time, repairs, and paving may be done upon the leased premises and the Lessee hereby waives any claim for damages to persons or property resulting from the use, occupancy or travel to and from the leased premises sustained by Lessee as a result of these activities.
8. Lessee shall keep the leased area and curtilage (areas adjacent) clean and shall not store any material or objects, except items or objects which are used in connection with the operation of aircraft while it is in flight or necessary for the storage of the aircraft.
9. Lessee shall not install or allow the use of telephones or two-way radios in the leased space.
10. Lessee stipulates that he/she has examined the demised premises, including the grounds and all buildings and improvements, and that they are, at the time of this lease, in good order, repair, and in a safe, clean and tenable condition. At the expiration of the lease term, Lessee shall quit and surrender the premises hereby demised in as good state and condition as they were at the commencement of this lease, reasonable use and wear thereof excepted. Lessee shall maintain in proper condition the fire extinguisher provided by the County.

11. The hangars shall be used only as a storage facility for the Lessee's own aircraft. FAA Registration # \_\_\_\_\_ (\_\_\_\_\_) and no other aircraft, vehicle or material(s). The demised premises shall be used and occupied by Lessee exclusively for the purposes of aircraft storage. Lessee shall comply with all sanitary laws, ordinances, rules, and others of appropriate governmental authorities effecting the cleanliness, occupancy, and preservation of the demised premises, and the curtilage connected thereto, during the term of this lease. Curtilage refers to any areas adjacent to the leased premises, such as the pavement in front of and beside the T-hangar. Lessee is solely responsible for the removal from the airport all trash, waste materials, garbage, and other refuse produced as a result of lessee's activities in the leased premises.
12. No storage, dispensing or transfer of flammable or combustible liquids shall be permitted inside the hangars with the sole exception of aviation fuel contained within the fuel tank(s) of the stored aircraft.
13. No person shall use any flammable liquids (with a flashpoint lower than 100 degrees F) to wash parts or to clean any section of an aircraft engine. Lessee shall not keep or have on the leased premises any article or thing of a hazardous, dangerous or explosive character that might unreasonably increase the danger of fire on the leased premises or that might be considered hazardous or extra-hazardous by any responsible insurance company or regulatory authority.
14. No smoking of any kind shall be allowed in hangars.
15. No person shall operate a welding machine or torch of any type in the hangars.
16. No person shall operate grinding equipment in the hangars.
17. No person shall perform any activity that could endanger the safety of the hangars or personnel or violate any environmental laws or regulations.
18. No hangar shall be used as a commercial business location, or in any way to generate revenues or reimbursement to the Lessee incident to the sale of materials, parts, maintenance for hire, fuel, sales, or other activities of a commercial or business nature, with the exception of aircraft flight instruction for hire.
19. No structural or electrical changes shall be made to the hangars by the Lessee without prior written permission from the County.
20. If the lessee removes the registered aircraft from the hangar for a period of more than one (1) month without written permission from the Airport Management, the Lessee will forfeit said lease. In such event, the Lessee will be given 10 calendar days to vacate the hangar. The Airport Director may make exceptions to the one month rule on a reasonable case by case basis.
21. Conviction of any felony, by the Lessee, will be grounds to terminate this lease. In such event, the Lessee will be given ten (10) calendar days to vacate the hangar.
22. If the premises are destroyed substantially by fire or taken by eminent domain, either party may terminate this lease without liability for the remainder of the term. A condemnation award shall belong exclusively to the County.

- 23. If any default is made in the payment of rent, or any part thereof, at the times hereinbefore specified, or if any default is made in the performance of or compliance with any other term or condition hereof, the lease, at the option of the County shall terminate and be forfeited and the County may re-enter the premises and remove all persons and property there from. Lessee shall be given fourteen (14) days notice of any default or breach, and termination and forfeiture of the lease shall not result if, within five (5) days of receipt of such notice, lessee has corrected the default or breach.
- 24. Waiver by the County of any breach of any covenant or duty of Lessee under this lease is not a waiver of a breach of any other covenant or duty of the Lessee, or of any subsequent breach of the same covenant or duty.
- 25. If suit is brought by the County for an unlawful detainer of the demised premises, for the recovery of any rent due the provisions of this agreement, or for any obligation of the Lessor arising under this agreement or by law, then Lessee hereby agrees to pay the County all of the costs in connection therewith, including, but not limited to, reasonable attorneys fees and court costs, whether or not the action or actions proceed to judgment.
- 26. This agreement is contingent upon the approval and acceptance by the Federal Aviation Administration, South Carolina Aeronautics Commission and any other appropriate Regulatory Authorities.
- 27. Invalidation of any part of this agreement by Court Order shall not affect the validity of the remaining terms hereof which shall remain in full force and effect.
- 28. This agreement shall be binding upon the parties and their heirs, successors and assigns and may not be assigned without the prior written consent of the other party hereto.
- 29. Oonce County may renew a lease in good standing on the same or different terms and conditions.

**Recommendation for Council Action:**

1. Award Bid #07-09 to Pickens Construction, Inc. for the amount of \$1,150,999.66.
2. Authorize staff to expend up to \$299,000 if needed for variations in quantities and unit costs and to purchase stone from our Rock Quarry.
3. Execute the attached contract.

**BACKGROUND OR HISTORY:**

In accordance with the Road and Transportation Committee's previous direction, staff is continuing to develop a detailed approach to declaring and tracking the costs of the annual paving contracts. This process calls for each road to have construction details spelled out and tracked for better quality work and cost control. Staff will provide project status updates for the 2007-2008 contract at each Road and Transportation Committee Meeting.

**BID SOLICITATION HISTORY:**

On November 1, 2007, formal sealed bids were opened for this contract. Five companies submitted bids, with Pickens Construction, Inc. of Anderson, SC, submitting the lowest bid of approximately \$1,150,999.66 (see attached Bid Tabulation).

**SPECIAL CONSIDERATIONS OR CONCERNS:**

The bids we received this year were the most competitive we have ever received. The spread between the lowest 4 bidders was only \$26,653.75, which is about 2.25% difference. The difference between the 2 lowest bidders was only \$5,152.34, which is about 0.45% difference. I attribute this to our ability to change the structure of our bid to unit prices and indexing, which has been accomplished through the efforts of the Roads and Bridges staff.

In January 2007, the South Carolina Department of Transportation specifications changed from Type 3 to Type C asphalt mix. The County's 2007-2008 bid package allowed vendors to bid on Type 3 as well as Type C. Although Pickens Construction did submit an alternate bid (\$9,200 less) for the Type 3 product, since it was only 0.799% less, staff determined that the County should proceed with Type C in this year's contract rather than postponing the change until next year. This will allow the County to be able to reallocate a portion of this contract to our anticipated 2007-2008 C-fund allotment when approved. The local funds could then be reallocated by County Council to either add additional resurfacing to the 2007-2008 contract or bid some "new work" separately. We have requested almost \$1,000,000 to be funded by the Oconee C-Fund program. Due to statewide cutbacks, we are unsure of how much funding will be received.

We are all aware that rising fuel costs continue to impact our road paving projects. Not only is the liquid asphalt content directly related to the cost of asphalt, but fuel cost for transporting materials is also increasing the overall costs. In an effort to minimize the exposure or risk of loss to the contractor, again this year, we are indexing the asphalt unit costs so that increases or decreases in petroleum products can be appropriately adjusted. The contingency referenced below would only be

used if needed; and would only be used for variances in quantities and unit costs for roads on the current list. No new roads will be added to the contract without County Council's approval.

We are reserving an additional \$550,000 to do "in-house" County Road paving projects and to contract out some much needed centerline stripping.

**STAFF RECOMMENDATION FOR COUNCIL ACTION:**

1. Award Bid #07-09 to Pickens Construction, Inc. for the amount of \$1,150,999.66.
2. Authorize staff to expend up to \$299,000 if needed for variations in quantities and unit costs and to purchase stone from our Rock Quarry.
3. Execute the attached contract.

STATE OF SOUTH CAROLINA

COUNTY OF OCONEE

THIS AGREEMENT made and entered into this \_\_\_\_\_ day of November, 2007, by and between OCONEE COUNTY, South Carolina (hereinafter "the COUNTY") and Pickens Construction, Inc. (hereinafter "the CONTRACTOR").

**1. SCOPE OF WORK**

- a. For and in consideration of the unit prices hereinafter specified, (see Attachment A), CONTRACTOR agrees to perform on behalf of the COUNTY certain roadwork and asphaltting at the direction of Oconee County, the total of such work not to exceed \$1,150,999.66 dollars. The Roads and Bridges Manager of Oconee County shall elect roads to be set-up and asphaltted by the CONTRACTOR at the prices stated in the contractor's bid proposal.

**2. PROGRESS PAYMENTS**

Payments are to be made for work described above on the tenth (10th) day of the month or as mutually agreed to in writing by the County and the Contractor. However, CONTRACTOR agrees to pay, as liquidated damages, the sum of one thousand (\$1000.00) dollars per day for all days in excess of agreed completion date listed below under Section 3, Contract Period.

Therefore, the COUNTY shall retain 10% of all payments to insure payments of any liquidated damages as may occur and to insure full compliance with the contract.

**3. CONTRACT PERIOD**

The Contract Period and effective term of the Agreement shall run on or about November 15, 2007 until June 15, 2008 unless the parties mutually agree in writing to extend the same.

**4. OBLIGATIONS OF CONTRACTOR**

- a. The CONTRACTOR shall furnish, for a contract price specified herein, all labor, materials, equipment, machinery and supplies necessary to perform and complete surfacing of the roads according to the general plans and specifications; to cause to be paid subcontractors, material, men and suppliers for such equipment, as well as any lessors thereof.
- b. CONTRACTOR agrees to comply with all Federal, state and local laws and regulations with regard to road construction and paving.
- c. CONTRACTOR shall employ certified personnel and equipment to prepare daily analysis reports that provide information regarding plant mix, including bitumen content, gradation, marshal stability. The COUNTY shall be supplied with a copy of this daily analysis report. If CONTRACTOR is running State work and COUNTY work simultaneously, the CONTRACTOR will submit a copy of the State's analysis report in lieu of a separate report for the COUNTY work. COUNTY reserves the right, at its discretion, to employ a qualified independent testing agency to perform testing at the plant site or from the product delivered to the job site, using

CONTRACTOR'S equipment at no additional cost to the COUNTY, to verify that specified mix design is being batched.

- d. Prior to any payments, CONTRACTOR will furnish to the COUNTY a performance bond and payment surety in the penal sum of \$1,150,999.66 dollars issued by a good and sufficient surety company licensed to do business in the State of South Carolina. Said bond shall be acquired by the CONTRACTOR at its own expense and provide appropriate provisions warranting that the construction and work performed by the CONTRACTOR or its employees or subcontractors shall be free of defects in workmanship and materials for a period of one (1) year from date of acceptance of the total contract by the COUNTY.
- e. CONTRACTOR will furnish to the COUNTY proof to the satisfaction of the County that the CONTRACTOR is licensed to do business in the State of South Carolina.
- f. CONTRACTOR shall submit proof of valid policies currently in force for worker's compensation insurance for all employees of the CONTRACTOR, as well as public liability insurance of at least \$5,000,000 limits.
- g. CONTRACTOR shall furnish at all times in all phases of construction qualified key personnel including, but not limited to, operators, laborers, one foreman, plus sufficient trucks and drivers.
- h. CONTRACTOR may assign only one crew at a time to COUNTY work, unless approved by the Oconee County Roads and Bridges Manager at least 24-hours prior to second crew beginning work. No asphalt work is authorized without an Oconee County Inspector on site. Any work done without an Oconee County Inspector present is subject to removal and replacement solely at the CONTRACTOR'S expense.

##### **5. DUTIES AND OBLIGATIONS OF THE COUNTY**

- a. COUNTY shall pay CONTRACTOR for work and service performed by it according to the provisions of this agreement in the manner specified herein.
- b. The COUNTY warrants that it has sufficient and valid right-of-ways for the roads upon which CONTRACTOR is to perform services. The COUNTY will, on a regular basis, consult with and be available for direction and designation of work to be done according to the terms of the Agreement, in such a manner as to prevent undue stoppage or delay of work on the part of the CONTRACTOR.
- c. Notwithstanding any other provisions of this agreement, the parties understand and agree that nothing herein shall require the COUNTY to designate any specific amount of work for the CONTRACTOR and its crew to perform and may elect to work or cause to be reworked only such of its roads as it deems to be in the best interests and needs, not to exceed the maximum contract sum specified herein, all without the consent of the CONTRACTOR.

##### **6. GOVERNING LAW**



Dear George,

In accordance with our telephone conversation yesterday, I am following up with this letter.

Yesterday morning, Jerry Mize, Executive Director of the Tribble Center, received a call from Phyllis Lombard acknowledging receipt of our annual audit report. During that conversation, Jerry was informed that the County contribution to the center would be reduced from \$75,000 to \$5,000. This came as most disturbing news, as we have been receiving a most generous and appreciated donation since the DSN Board was first established some 30 years ago. Initially, that contribution was \$25,000, but was increased to \$75,000 five years ago in 2002.

The Oconee County DSN Board has established itself as one of the best managed boards in the state, and operates very efficiently with the limited funds it receives. We have an annual budget of \$6.2 million, and although most of the funding is from the state and federal governments, that only amounts to \$5.5 million, and supports only the very basic operating necessities. In order to provide a better quality of life for the nearly 500 individuals who receive various services, more than \$700,000 must be raised from other sources. This includes work activity contracts and contributions from numerous sources, including United Way, many individuals, local organizations such as the Seneca Sertoma Club and the Knights of Columbus, The Dryfus Foundation, and the Oconee County Council. Each and every one of these most generous supporters is not only appreciated, but we depend on their contributions to offer the care we are able to provide.

In fact, earlier this year, I wrote a letter to the County Council, requesting an increase in your annual contribution to assist us with ever increasing costs. One of the most noticeable cost increases comes from the price of gasoline. Our agency operates 47 vehicles to transport consumers and perform other required transportation needs, and the resulting cost increases are most obvious. Unfortunately, that request was denied.


**MONDAY CORNER** — Berkeley County taxpayers will have to foot a very hefty bill to build up hundreds of millions of dollars for 31 new schools in the next three decades if the massive Parks of Berkeley development moves forward as planned.

School district officials estimate that "Classroom Reserves" plans for nearly 18,000 homes will increase the school population by one-third over the next

30 years. That's not counting neighborhood developments such as Caine Ridge and Corinn Courtlands, which together with Parks of Berkeley account for about 25 percent of the county's planned growth and are expected to increase the student population by 30 percent. The county has 25,000 students now.

The estimated 30,000 students will be enough to construct a 400-classroom elementary with three times the land area as the

An Ordinance Amending Ordinance 2007-09, Sign Control Ordinance of Oconee County, South Carolina, Specifically Creating Standards to Regulate Temporary Signage.

WHEREAS, Oconee County adopted Ordinance 2007-09, the Sign Control Ordinance of Oconee County, South Carolina, to regulate negative secondary impacts of signage; and

WHEREAS, well maintained, safely located event-specific temporary signage is an appropriate advertising medium; and

WHEREAS, the effectiveness of event-specific temporary signage is limited to the time prior to an event; and

WHEREAS, failure to remove event-specific temporary signage often degrades the beauty of scenic areas and negatively impacts the quality of life enjoyed by Oconee citizens; and

WHEREAS, Oconee County's citizens and taxpayers are unduly burdened by the costs of the cleanup and remediation of abandoned and degraded temporary signage;

NOW THEREFORE, BE IT ORDAINED by the Oconee County Council in session, duly assembled with quorum present and voting, the following:

Ordinance 2007-09, Sign Control Ordinance of Oconee County is hereby amended as follows:

1) Section 4, Terms and Definitions, shall include:

Event-Specific Temporary sign - a sign or advertising display intended to be displayed in connection with a specific event or activity for a limited duration.

2) A Section 11 entitled "Requirements for Temporary Signage" is hereby created, and shall contain the following regulation:

- A) Event-specific temporary signs so constructed and located as to present no health and safety hazards to the general public shall be allowed within the public right-of-way without a sign permit; however, all such signs shall be removed from the public right-of-way, or any other public property for which appropriate permission

was granted to placement of said signage, no later than seven (7) days after the event the signs are promoting.

- (3) Event-specific temporary signs displayed longer than seven days after the event for which the sign promoted, or signs which are not maintained in an safe, attractive manner, may be considered litter and subject to the provisions of the Oconee County Litter Control Ordinance 2006-10, as amended or may be considered a violation of this Ordinance and subject to the penalties section set forth in Section 9 of this Ordinance.

INTERGOVERNMENTAL  
AGREEMENT

THIS INTERGOVERNMENTAL AGREEMENT, made and entered into this \_\_\_\_\_ day of November, 2007, by and between OCONEE COUNTY, South Carolina, hereinafter called "the County", and the CITY of WESTMINSTER, hereinafter called "the City", and is hereby contracted and agreed by and between the parties hereto as follows:

The governing bodies of the COUNTY and the CITY have found this Agreement to be in the best interest of the public and each has approved this Agreement and authorize the execution by the undersigned officers.

NOW THEREFORE, in consideration of the terms and conditions herein, the parties do hereby agree as follows:

**ARTICLE I**

**FACTUAL BACKGROUND**

**Section 1.01**

- 1) The CITY is a municipal corporation duly chartered by the State of South Carolina and pursuant to applicable constitutional and statutory provisions relative thereto. The CITY is fully empowered to enter into this Intergovernmental Agreement.
- 2) The COUNTY is a body corporate and politic of the State of South Carolina which is governed by a County Council and which, by virtue of the Constitution of the State of South Carolina, as well as other enabling legislation, is fully empowered to enter into this Intergovernmental Agreement.

- 3) The COUNTY desires to upgrade its Emergency Protective Services facilities. The CITY desires to upgrade its Fire Protection facilities.
- 4) On July 1, 2007, the COUNTY and CITY entered into an Intergovernmental Agreement whereby the CITY has agreed to provide fire protection in certain portions of the unincorporated areas of the COUNTY.
- 5) The COUNTY and CITY agree that a joint facility will help satisfy the immediate need of both the COUNTY and CITY for an Emergency Protective Services facility and fire station at a reduced cost to both the COUNTY and CITY. In addition, a joint facility would improve the efficiency of both the COUNTY and the CITY and prevent a duplication of services and supplies.

#### AGREEMENT

The COUNTY and CITY mutually agree, each with the other, as follows:

#### ARTICLE II

#### PHYSICAL FACILITIES

##### Section 2.01

- 1) The CITY of Westminster will exercise an option to purchase 14.95 acres located within the city limits of the City of Westminster. The CITY will purchase said property to be used by the COUNTY and the CITY for the County's Emergency Protective Services Department and the Westminster Fire Department.
- 2) The CITY of Westminster shall provide the following infrastructure to the property for use by the COUNTY and CITY: water facilities, sewer facilities, electrical, and satellites.
- 3) The CITY agrees to enter into a ninety-nine (99) year lease with the COUNTY for

the real property. The lease will be structured to enable the COUNTY to insure the facility.

4) The CITY agrees to provide a 30' X 80' metal building to be used on the property by both the COUNTY and CITY.

**Section 2.02**

1) The COUNTY agrees to build a building adequate to accommodate the COUNTY's Emergency Protective Services Department and the Westminster Fire Department. The building cost is estimated to be \$3.5 million dollars pursuant to a design by architect Danny Ard.

2) The COUNTY shall be responsible for the cost of any training facilities that are placed on the property.

3) The COUNTY agrees to waive any tipping fees for the disposal of the materials currently on the property that need to be removed in order to fulfill the parties' obligations under this Agreement. In addition, the County agrees to waive the C and D tipping fee for the disposal of the current Westminster Fire Department if recyclable materials are removed from the C and D waste.

4) The COUNTY shall be responsible for the following infrastructure to be provided to the facility: cable television, telephone lines and gas lines.

5) In the event the City of Westminster wishes to assess a change order in the construction of the building or increase the cost of the building, the change must be agreed upon by both the COUNTY and the CITY.

ARTICLE III

OPERATIONAL AGREEMENT

Section 3.01

1) The CITY shall be responsible for providing the furnishings to the portion of the building the CITY will be occupying. The COUNTY shall be responsible for furnishing the portion of the building that the COUNTY will be occupying. The parties agree to split the cost for furnishing the portion of the building that will be used as common areas.

2) The COUNTY shall be responsible for providing building maintenance on the building.

3) The CITY shall be responsible for housekeeping in the area which the CITY occupies. The COUNTY shall be responsible for housekeeping in the area which the COUNTY occupies. The parties shall split the housekeeping duties in the portions of the building that are common to both.

4) The CITY shall be responsible for the payment of the water bill, electrical bill, sewer bill, and satellite bill for the facility. The COUNTY shall be responsible for the gas and cable bill for the facility. The COUNTY and CITY shall be responsible for their own respective telephone bills. In the event that in the future the COUNTY charges the CITY a tipping fee for municipal solid waste, the parties agree to split the cost for the disposal of solid waste generated at the facility.

5) The cost of equipment that is replaced and is used by both parties shall be split by the parties.

6) The COUNTY and CITY shall each buy their own respective supplies for their individual operations. The parties shall split the cost of supplies that are used by both parties in the areas of the facility that are jointly used.

#### FUTURE EXPANSION

##### Section 4.01

1) In the event that the facility needs to be expanded in the future, the parties will negotiate a cost of the expansion.

2) In the event that the City decides to cease operations of its fire department at the facility, the County shall have the option to purchase the property from the City for the same amount the City paid for the property and utilize the entire facility. If the County does not exercise this option, the City may utilize its space for another City operation so long as the operation does not interfere with the County's Emergency Protective Services Department. In the event the County decides to cease operations of the Emergency Protective Services Department, the City may allow the County to utilize the space in the building that the County was using for another County operation, so long as the operation does not interfere with the operation of the City's fire department. In the alternative, the City may request that the County abandon the facility. If the City requests that the County abandon the facility, the City shall pay to the County the County's building cost of the facility based on a pro rata cost of the facility over twenty years from the date the facility is completed. If the County decides to cease its operations after twenty years from the date the facility opens, the City shall have no obligation to pay a pro rata cost of the facility.
