
# OCONEE COUNTY BOARD OF ZONING APPEALS

Mr. Richard Cottingham presented the expansion plans to the Board. Mr. Tim Hedrick also gave information concerning the expansion of the Cabana.

Mr. Cottingham responded that they have 10 boat slips, 4 tie ups, and capacity is rarely an issue.

Mr. Lee asked about the amendment in the ZEO concerning expansions to nonconforming uses going before the Board.

Mr. Stephens informed Mr. Lee that the permit was issued before the amendment took effect.

Mr. McKee made a statement concerning the hill between the restaurant and the Cabana and the undue hardship incurred.

Mr. Littlefield seconded the motion. The motion passed 5-1 Mr. Nichols dissenting.
