The Budget, Finance & Administration Committee on Saturday, May 16, 2009 at 9:00 AM in Council Chambers to review the proposed FY 2009-2010 Oconee County budget. All Council Members were present along with Elizabeth G. Hulse, Clerk to Council.

## **Call to Order:**

Chairman Dexter called the meeting to order at 9:00 a.m.

### **Approval of Minutes:**

Deferred to a future meeting.

#### Final Line by Line Budget Analysis for FY 2009-2010:

[unless otherwise noted the following departments were approved for the administrator's recommended budget amount with the proviso that they may be revisited in a future meeting]

o Emergency Services, Dept 107 [Revised Handout provided from Law Enforcement, Public Safety, Health & Welfare Committee]

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4 - 0 to authorize the addition to the FY 09-10 budget for the lease purchase for two fire trucks in the approximate amount of \$750.000.

Mr. Thrift made a motion, seconded by Mr. McCall, approved 4 – 0 to remove \$750,000 of fund balance noted on the Other Financing Sources/General Fund [page 11 of the proposed budget].

- Emergency Services Fund 20 [Revised Handout provided from Law Enforcement, Public Safety, Health & Welfare Committee]
- Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4-0 to increase Overtime by \$12,000 for a total approved amount of \$36,000.
  - o Magistrate Office, Dept 509
- Mr. Suarez made a motion, seconded by Mr. Thrift, approved 4 0 to amend line item 010-509-30084 adding \$1,300 for a total approved amount of \$6,100.
  - o Roads, Dept 601

Committee requests that the County Engineer made a priority listing of roads in dire need of paving/patching for presentation to the Transportation Committee at a future meeting.

- o Vehicle Maintenance, Dept 721
- Mr. Suarez made a motion, seconded by Mr. McCall, approved 4 0 to amend line item 010-721-40034 [Food] adding \$500 for a total approved amount of \$500.
  - o Treasurer, Dept 306
- Mr. Nowell, Treasurer, requested the Committee to enter into Executive Session for the purpose of discussing a personnel matter in his office.

## **EXECUTIVE SESSION:**

Mr. Thrift made a motion, seconded by Mr. McCall, approved 4 - 0 to enter into Executive Session for the purpose of discussing a personnel matter.

The Committee entered Executive Session at 10:25 a.m.

The Committee returned from Executive Session on a motion by Mr. Suarez, seconded by Mr. McCall, approved 4-0 at 11:08 a.m. Mr. Dexter noted that no action was taken during Executive Session.

Mr. Thrift made a motion, seconded by Mr. McCall, approved 3 - 1 to reclassify a part time position to full time in Department 306.

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4 – 0 to amend line item 010-306-30025-0 adding \$4,000 for continued security of the Tax Center in December 2009 and January 2010.

Mr. McCall made a motion, seconded by Mr. Thrift, approved 4 - 0 to amend line item 010-306-40031 adding \$2,000 for a total approved amount of \$3,800; and to amend line item 010-306-30025 by reducing the approved amount to zero dollars.

- o Finance, Dept 708
- Mr. Thrift made a motion, seconded by Mr. McCall, approved 4 0 to amend line item 010-708-30025-0 [Professional] removing \$1,150 for a total approved amount of \$16,500.
  - o County Council, Dept 704
- Mr. Suarez made a motion, seconded by Mr. Thrift, approved 4 0 to move the Sewer System Agreement funding in the amount of \$200,000 from the Council budget to Direct Aid [creating a new line item number].

# **External Budgets Discussed:**

o Tri County Technical College Budget Request

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4 - 0 to approve the Tri County Budget Request in the amount of \$972,117.

o Keowee Fire District Budget Request

Mr. Suarez made a motion, seconded by Mr. Thrift, approved 4 - 0 to approve the Keowee Fire District Budget Request in the amount of \$657,100

o Oconee County School District Budget Request

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4 - 0 to approve the Oconee County School District Budget Request in the amount of \$56,398,014.

## **Miscellaneous Finance Recommendations for the Budget:**

Ms. Kendra Brown provided the committee with a worksheet outlining recommendations for additional budget cuts. The Committee discussed each and actions were taken as reflected on Attachment #1 [filed with these minutes and a part of the permanent record].

### **Breaks:**

The Committee took a 10 minute break at 9:45 a.m.

The Committee took a lunch break at 11:59 a.m. and returned to open session at 12:46 p.m.

## **EXECUTIVE SESSION:**

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4-0 to enter into Executive Session for the purpose of discussing personnel matters related to the FY 2009-2010 budget.

The Committee entered Executive Session at 12:46 p.m.

The Committee returned from Executive Session on a motion by Mr. Thrift, seconded by Mr. Suarez, approved 4-0 at 1:54 p.m. Mr. Dexter noted that no action was taken during Executive Session.

Mr. McCall made a motion, seconded by Mr. Suarez, approved 4 - 0 to freeze hiring the two vacant fire fighter positions in Department #107 and remove the funding from their budget.

Mr. Thrift noted that after long discussion in Executive Session that he was making a motion, seconded by Mr. Dexter, approved 4 – 0 to institute for FY 2009-2010 a mandatory 4 day furlough for all county employees [except Public Safety] to be taken per guidelines that will be forthcoming and voted upon at a future Budget, Finance & Administration Committee meeting. As part of the motion Mr. Thrift also stated that it is Council's wish that Elected Officials honor and impose the 4 day furlough in their departments, however, if they do not monies equal to furlough cost saving for their staff will be removed from their individual operating budgets for FY 2009-2010.

Mr. Thrift made a motion, seconded by Mr. Suarez, approved 4-0 to authorize the Finance Department to use excess revenues over expenditures to reduce the budgeted fund balance used in the FY 2009-2010 budget.

# **Other Issues Discussed:**

## **Budget Ordinance for Oconee County:**

Ms. Brown provided the Committee with a draft budget ordinance and addressed each section to obtain input.

## **Jail & Courthouse Funding:**

Mr. Dexter noted that discussion needs to take place regarding funding options related to the Jail and Courthouse.

Mr. Dexter made the following announcement regarding upcoming budget meetings:
