Call to Order:

Approval of Minutes:

Discussion Regarding Requesting a Portion of the County's Recycling Revenue & Other Potential Revenue Sources

Mr. Prater asked if the county charged mitigation fees for developments and if so could some or all of those fees be allocated to the OCCB.
