Call to Order:

Mr. Airey called the meeting to order at 9:00 a.m.

Donation Presentation to Conservation Bank Board

Mr. Airey recognized Mr. Eddie Martin, Oconee County Soil & Water Conservation District, who addressed the Board and presented the chair with a \$1,000 donation from Oconee Forever. Mr. Martin noted that these funds were the proceeds for the Rally in the Valley event in May 2013.
