# Director Krein's Report

- Fire Chief Larry Greer is on board as of next week.
- Getting names of first responders including police to get the vaccine to them. Encourage your Departments to get the vaccine. In 2 weeks offer goes out to others.
- ISO inspection completed virtually. Brady worked hard at that. No word yet.
- AFG: 150 air packs being applied for (\$71,000-\$75,000). Need replacement in 2 years. Some packs may stay. All cylinders need replacement. Apply again if needed. 3<sup>rd</sup> party Flow testing air packs now. Have spent thousands of dollars to keep them repaired this year. Use Scott or MSA, whichever is best for the county but be uniform in the county.
- Due to COVID, March delivery for first 6 fire trucks. Sept./Oct. last 2 which were just ordered. (piggybacked on first order). Saved 10% increase or \$35,000-\$40,000. Inspections done when trucks are completed. Working on Replacement Plan.
