LOW INCOME SPAY/NEUTER ASSISTANCE PROGRAM (SNAC)

FISCAL YEAR JULY 1, 2014 to June 30, 2015
AND CURRENT FISCAL YEAR JULY 1, 2015 to March 31, 2016

The COMBINED EFFORTS of Animal Control, the LEC, the Oconee Humane Society, Oconee County, and responsible pet owners have made a positive impact on making SNAC an overall success. We are on track to sell 300 more certificates this fiscal year than last year. Shelter intake has been reduced by 29%. Adoptions have increased 60% since 2010.

The continued funding of this program is imperative if we are to have success in lowering the overall unwanted pet population and lower operational costs at the shelter. The Humane Society continues to operate the SNAC Program with volunteers and paid staff.

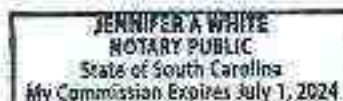
