Treasurer's Report **Phil Shirley** presented the treasurer's report. Balance as of **May 15, 2015** for Local ATAX is \$198,276.00 and State ATAX is \$55,313.00 Phil Shirley gave the commission members a handout showing a breakdown for the Mountain Lakes Convention & Visitors Bureau funding for 2015-2016 budget year. He asked the commission to consider funding the CVB for \$132,000.00. Mr. Shirley spoke on upcoming events for the 2015-2016 year and asked the commission members to consider funding the following events: Road Titans (\$15,000); Mystery Fishing (\$15,000); Fishing District Championship (\$7,500). These events will bring numerous cyclists, anglers, their families, and tourist to our area which, in turn, will bring economic dollars to the area. He also suggested that the commission members request approval from County Council to give the Oconee Heritage Museum \$30,000 for repairs to the HVAC units. Phil Shirley gave an update regarding the ADA fishing pier at South Cove, the new South Cove office and the disc golf course at Chau Ram.
