Vote was unanimously carried. **Treasurer's Report** Phil Shirley presented the treasurer's report. Balance as of May 12, 2016 for Local ATAX is \$185,107.00_____ and State ATAX is \$60,398.00____. Mr. Shirley spoke on upcoming events for the 2016-2017 year and asked the commission members to consider funding the following events: FLW-BFL Regional Fishing Tournament (15,000); Road Titans (up to \$25,000). He also asked the commission members to consider the funding of gravel to Chau Ram Park's disc golf course (\$12,000). These events will bring numerous cyclists, anglers, their families, and tourist to our area which, in turn, will bring economic dollars to the area. Phil Shirley gave the commission members a handout showing a breakdown for the Mountain Lakes Convention & Visitors Bureau funding for 2016-2017 budget year. He asked the commission to consider funding the CVB for \$152,000.00. **New Business** ➤ Upon a motion by Rosemary Bailes, seconded by Rick Lacey carried, the Committee approved motion to recommend to County Council to fund the FLW-BFL Regional Fishing Tournament for \$15,000.00 . Vote was unanimously carried. ➤ Upon a motion by <u>Becky Wise</u>, seconded by <u>Dan Pollock</u> and carried, the Committee approved motion to recommend to County Council to fund **Road Titans** up to\$25,000.00_. Vote was unanimously carried. ➤ Upon a motion by Rosemary Bailes, seconded by Dan Pollock and carried, the Committee approved motion to recommend to County Council to fund \$12,000.00 for gravel for Chau Ram County Park's disc golf course. Vote was unanimously carried. ➤ Upon a motion by <u>Rick Lacey</u>, seconded by <u>Becky Wise</u> and carried, the Committee approved motion to recommend to County Council to fund the Mountain Lakes Convention & Visitors Bureau \$152,000.00_

for the **2016-2017 budget year.** Vote was unanimously carried.
