Balance as of **May 5, 2022**, for Local ATAX is \$524,131.00 and State ATAX is \$369,280.00 **Action Items** > Upon a motion by <u>Kevin Evans</u>, seconded by Greg Coutu and carried, the Committee approved motion to amend the recommended FY23 Supplemental ATAX Budget_of \$437,312.00_ for an additional \$8,000.00. A copy of the Supplemental budget will be included with the agenda item to Council. Vote was unanimously carried. ➤ Upon a motion by <u>Shawn Johnson</u>, seconded by <u>Greg Coutu</u> and carried, the Committee approved motion to recommend to County Council the **FY23 Supplemental ATAX Budget** for \$445,312.00. A copy of the Supplemental budget will be included with the agenda item to Council. Vote was unanimously carried. > Upon a motion by **Shawn Johnson**, seconded by **Kevin Evans** and carried, the Committee approved motion to recommend to County Council the use of \$289,761 in 65% State ATAX funds for the Visit Oconee SC 2022-2023 budget year. Vote was unanimously carried. ➤ Upon a motion by <u>Shane Smith</u>, seconded by <u>Shawn Johnson</u> and carried, the Committee approved motion to recommend to County Council the use of 30% State ATAX funds for the Visit Oconee SC 2022-2023 budget year. The estimated 30% State ATAX revenue is \$120,000. This fund is market dependent quarterly and subject to change slightly based on statewide accommodations. Vote was unanimously carried.
