# Item 1: Call to Order

Mr. Honea called the meeting to order.

#### **Item 2: Approval of Minutes**

Ms. Heller made a motion to approve the minutes from the June 4, 2012 meeting; Mr. Moore seconded the motion. The motion passed unanimously.

#### **Item 3: Public Comment**

**Mr. Tom Markovich** said that rezoning the Public lands is pointless and that it would prevent any developer from performing their due diligence.

**Mr. Larry Linsin** stated that the Federal government and its agencies have supremacy of the State and its counties and that Oconee County had not enforcement power of the federal lands.

**Mr. Phillip Collins** stated that he has land adjacent to the national forest and wanted to know how it would affect him.

## Item 6: Discussion and Consideration of Ordinance 2012-25 "Mountain Springs"

Mr. Stephens presented to the Commission the Mountain Springs request. Mr. Abbott made a motion to recommend the request as petitioned with the additional public input parcels included and for staff to contact those who are surrounded including the Beaver Lake subdivision owners. Mr. Moore seconded the motion. The motion passed unanimously.

Mr. Stephens informed the Commission that Attorney Larry Brandt had appealed staffs decision to put forward the petitions for Biggerstaff rezoning to the BZA.
