

On July 18<sup>th</sup>, 2013, we received a notice from the Office of Oconee County Addressing Office that apprised us of their intent to change our address from 819 Rockcrest Way to 820 Rockcrest Way. This letter is to inform you that we oppose that request on the grounds of undue burden, hardship, and result of the extraordinary associated costs surrounding that address change.

We have owned Lot 67 on Rockcrest Way since 2003 and the lot has had the designation of "819 Rockcrest Way" for nearly 10 years. As a consequence and <u>reliance</u> on the fact that we believed that to be our address, we began to change numerous legal and non legal documents to 819 Rockcrest Way. We are not part time residents but reside at the above address on a full time basis.

To change our address today, would require us to chance numerous US federal documents such as US Social Security, US Tax Documents and previously submitted IRS returns, US Bonds investment instruments, pension documents, and mortgage documents. In addition, bank accounts, brokerage accounts, insurance documents, deeds, county records, state tax records, driver's licenses, and utility records would also have to be changed.

We fail to understand how this occurred and why action has not been taken to correct this some time ago. Indeed, we have had numerous states and county officials come to our house and no one has suggested that our address is incorrect or otherwise improper. If we had just purchased the property or if we were part time residents, changing an address might be an achievable task. But we aren't and 10 years has transpired!

As a consequence of the above and the undue hardships and costs that would result, we respectively request that we be exempted from the request to change our address. Please feel free to contact us if we answer any questions.

Ms. Winchester:

This morning I drove to Rockcrest Way in Salem, SC in response to a written appeal from property owners John and Janet Sharp.

The Oconee County E-911 Addressing Office has notified the Sharp's that it intends to change their street address from 819 Rockcrest Way to 820 Rockcrest Way. The Sharp's filed a written appeal on August 7, 2013.

I observed that the street is numbered such that even numbers are on the right side of the street and odd numbers are on the left side of the street, until one reaches 819. This residence is on the right side of the street immediately adjacent to 818.

From a public safety response standpoint, this causes confusion. A responder, particularly in a low-light condition, relies on an orderly addressing system by which to locate a residence during an emergency situation. Following the scheme in place, the responder should immediately observe the even numbers on the right and odd numbers on the left and begin looking to the left, counting residences in an effort to quickly find their destination. In the case of Rockcrest Way, this standardized method of locating a residence would fail.

Further, it appears that there is opportunity for further construction beyond 819. The issue would be further compounded should more addresses be assigned beyond 819 which begin again to conform to the addressing standard.

It is my opinion that without a standardized street numbering scheme in place that can be quickly recognized by emergency response personnel, there is a great risk for a delay in locating 819 Rockcrest Way and future developments on the street. Such a delay increases the opportunity for loss of life or property during an emergency such as a fire, medical situation, or home invasion.

Therefore, I support the decision of the Oconee County E-911 Addressing Office to change the address of 819 Rockcrest Way to 820 Rockcrest Way.




Brown Adjacent Rezoning Request

## Background

- The proposed ordinance, 2013-34 (Brown Adjacent), stems from a request submitted by Mr. George P. Brown Jr. The request consists of 1 parcel totaling 105 acres along Forest Path Trl. in the Walhalla area. The parcel is located in the rural suburban area on the Future Land Use Map
- The parcel is adjacent to a parcel that was rezoned into the Traditional Rural District on 12/06/2011 (2011-18 Neville Request).
- As submitted, parcel131-00-02-021, currently in the Control Free District, would be rezoned into the Traditional Rural District.


#### Public Input Received to Date

 A nearby property, upon receiving the 1<sup>st</sup> Reading Notice, came in to discuss the request and mentioned an interest in joining the request. However, no petition has been submitted by this owner.

#### Staff Recommendation

- This rezoning request is located in the Rural Suburban area on the FLUM;
- The district requested complies with the Comprehensive Plan and with what Council has previously adopted in this area on the FLUM;
- The Commission should consider all public input received to date;
- Staff recommends TRD for the area under consideration;
- With the consensus of the Commission staff will develop other alternatives for consideration.
