- 1. Call to Order Mr. Pearson called the meeting to order at 5:59pm

Mr. Barnett reminded the commission that the Constitution keeps you out of trouble. He also stated that he believes the Corridor Plan will lead to zoning.

6. Comprehensive Plan 2030

- a. Public Comment Mr. Markovich pointed out:
 - 7-1 mentions that Oconee County was created in 1868, but that is incorrect, there
 were no counties, there were districts and Oconee was created from the Pickens
 District.
 - 7-3 All jurisdictions must have (needs to be may have) planning commission.
 - 7-3 The duty of the Planning Commission that tends to get overlooked is that all planning elements must be an expression and planning commission recommendations to the appropriate governing bodies with regard to the wise and efficient use of public funds. Also to consider is the physical impact of the property owners.
 - 7-4 Mr. Markovich states that outside of water service area you're in a section of property that's being developed by a developer and the developer pays for those water lines and that cost gets built in. Also, Water treatment is primarily provided by 4 plants (not 2). Westminster and Pioneer need to be added.
 - Table 7-2, Testi is spelled Tesi.
 - 7-6 Developer pays it's not an extra cost. It is incorporated in the land price. Also slope has nothing to do with septic tanks.

- 7.1.1.1 Mr. Smith made a motion to ask Alta to reword this to add "expand service and encourage collaboration to share their resources." Mr. Vassey seconded and approved 6/0.
- 7.1.2.5 Mr. Johnson made a motion to remove this Strategy, seconded by Ms. Lyles, Approved 6/0.
- 7.1.2.5 Mr. Smith made a motion to add the Strategy "Encourage septic tank and leach field education" with Oconee County and SCDHEC as the Accountable Agencies. Seconded by Ms. McPhail. Approved 6/0.
- 7.1.3.2 Mr. Smith made a motion to remove this strategy and make it the objective, with how and when being the Strategy. Mr. Smith seconded, Approved 6/0.
- 7.2.1 Ms. McPhail made a motion to change the wording to Seek local, state, federal, and community funding... Mr. Johnson seconded, approved by all.
- 7.2.1.3 Ms. Lyles made a motion to remove the words "and the location of schools" Mr. Johnson seconded, approved by all.
- 7.2.2.1 & 7.2.2.2 A motion was made by Ms. McPhail, seconded by Ms. Lyles and approved by all to remove these two strategies.
- 7.2.2.3 Ms. McPhail made a motion, seconded by Mr. Smith and approved by all to add Municipalities to the Accountable Agency.
- 7.2.3.3 Mr. Vassey made a motion to remove this Strategy, seconded by Ms. McPhail and approved by all.
- Add 7.2.3.8 Ms. McPhail made a motion to add "Communicate frequently with the citizens of Oconee County about emergency plans." with Oconee County as the Accountable Agency. Mr. Pearson seconded, approved 6/0.
