- Region 2 Squads 2 & 6 / Tammy Wilbanks No issues as far as Salem is concerned, about 300 calls which is up. Epi and Narcan training is proposed for December 1, 2020. One new member at this time. Mountain Rest is currently going through he refresher class.
- Region 3 Squads 4 & 5 / Michael Smith Nothing new with Rescu4 Rescue 5 has 5 new members that are ready to start responding.
- Region 4 Squad 22 / Erik Sprogis Epi and Narcan training was last month. One potential new member.
- Region 5 Squads 7 & 8 / Steven Zahn Busy with calls, new truck, and Dive has 4 new members.

#### **Commission Chairman Steven Zahn's Report**

- 1. - 4. Responder opportunity Clinics are coming up and responders need to know about them.
