

# MINUTES OCONEE COUNTY CAPITAL PROJECT SALES TAX COMMISSION October 22, 2013

### **Call to Order:**

Mr. Price called the meeting to order at 1:00 p.m.

### **Approval of Minutes**

Ms. Miller made a motion, seconded by Mr. McPheeters, approved 4 - 0 to approve the minutes from the October 17, 2013 meeting as amended.

#### **Updated Draft Project Submittal Form v2**

Mr. Price led discussion regarding the Project Submittal Form v2. Discussion followed. Wording for one section and a date correction were noted.

Mr. McPheeters made a motion, seconded by Ms. Miller, approved 4 – 0 to approve the four forms [Project Criteria Questionnaire, Reviewer Scoring Sheet, Project Scoring Summary Sheet and Project Submittal Form] as amended.

Mr. Price requested that Ms. Hulse made the Questionnaire and Submittal Form available to the public.

## New Business

### Discussion regarding Public Awareness Campaign

Mr. Price led discussion regarding a public awareness campaign. Topics discussed included public notification that the submittal period has begun to include the Chambers of Commerce, Economic Development, all municipalities, civic groups, Industrial Group, etc., and advertisement in the local paper regarding the acceptance of projects. Discussion followed.

Mr. McPheeters made a motion, seconded by Ms. Miller, approved 4 – 0 to direct the staff liaison to place advertisement in the local paper regarding the open submittal period for projects.

#### **Presentation to County Council**

Mr. McPheeters suggested that the Commission should make a presentation to County Council regarding progress to date and to advertise the open period for project submissions. Discussion followed. Ms. Miller and Mr. McPheeters agreed to make a brief presentation to Council at their November 19, 2013 meeting. Mr. Price requested that Ms. Hulse assist in coordination and preparation of a PowerPoint presentation for that meeting.
