

#### ECONOMIC DEVELOPMENT DIRECTOR'S REPORT - March 12, 2013

\*This report represents activity from February 13, 2013 – March 12, 2013.

### **Status of On-Going Projects:**

- **Project Cover III** This project, AID, continues to take shape in the former Spec building with steel rising and up-fit taking place. The EDC office is still working with company on small items to help them get established.
- **Project Zeta** Project as issued their letter of intent to locate this project in Oconee. They are looking at a \$1.2m capital inv'st with 7 new jobs. This is a data center/back office type project. This project is currently working through County Council.
- **Project May** EDC continues to work with this existing industry's expansion plans. Waiting for approval on expenditures related to a new product line.
- **Project Peninsula** This is a \$120 million dollar project and it has formerly announced as Sanctuary Pointe. The EDC team is now meeting every two weeks with this project.
- **Project Mole** Existing Company that is considering an expansion in 2013. They are working to get the approvals in place to move forward.
- **Project W** This project is awaiting confirmation from corporate leadership to move forward with their plans.
- **Project Fluid** Continued discussions with an existing industry about expansion opportunities.
- **Project Gear** Continued discussions with an existing industry about expansion opportunities.
- **Project CreekSide** Still working with the company and trying to "nail-down" their plans and next steps.
- **Project San** Existing Company that is considering an expansion. Recently met with them and Duke Energy about some issues surrounding their plans. All positive.
- **Project Bory** Existing Company that has 2013 expansion plans. Met with several times to firm up the ideas but waiting for confirmation via corporate.
- Project Gizmo & GDA Existing Company that we have worked with and got the state involved.
   SCDOC made an incentive proposal to the firm; waiting game for approval. Also a second project involved with same company.
- **Project Science** New company that has visited and we met with about relocating to this community. This is a research type company recently made another visit last week to building.
- **Project Plant 5** Submitted Oconee building options for this project via the SC DOC. Awaiting next steps.
- **Project Court** This is the Walhalla hotel project. Meetings with developers continue. The incentive package is before council currently.
- **Project Riverside** This is a new project from out-of-state that we have had dialogue with about locating their process to Oconee.
- **Project Box** Existing Oconee Company looking at upgrades to facility. Awaiting next steps from corporate.
- **Project Redhouse** Site selection driven project that is geared towards Agribusiness. Oconee made it into Phase II of the search.

- **Project Astro** Oconee was narrowed down to the only site being focused on in South Carolina. Working with SCDOC on this one and awaiting next steps from corporate.
- **Project Danish** Oconee was eliminated due to proximity to Charlotte.
- **Project Three Rings** Oconee submitted a building for consideration on this project but was eliminated due to not being in a "metro area."
- **Project Blossom** Oconee submitted the Jacob's Chuck building for the food processing type project. Unfortunately, due to prior use of building...we were cut.
- **Project Sanitizer** Oconee submitted three properties for consideration for this project.
- **Project Smiley** The project has chosen another county in the low country.
- **Project Lexar** After viewing the area, the company decided not to move from Virginia location.
- **Project Tub** –This project has delayed their relocation plans at this time.

### **Organization Activities:**

- Golden Corner Commerce Park Master Plan Met with engineering firm about a feasibility analysis for sewer and roads. Applied for C Funds to cover costs (survey and road layout) and was approved. New survey for Pioneer Water finished. Also continued discussions about the transmission lines. Both issues are now in-hands of legal team due to conveyance of land.
- Upstate Alliance Board Meeting Attended this session with Mr. Corbeil and Mr. Eldridge.
- **SCEDA Membership Meeting** Attended this session.
- **State of Oconee** Presented at this Chamber meeting.
- **Moore Site** Met with owners and broker on this site. Submitted this property for the Duke Readiness Program.
- Meeting with Rick Cothran (TCTC) Met to discuss grant opportunities.
- **Meeting with John Hamrick** Met to discuss properties in the area.
- SC Power Team "Economic Development Review" Attended this meeting and spoke at this event on economic development in Oconee County.

- Presentation / Walhalla Lions Talked about economic development in Oconee.
- **Retention / ITron** Met with principals of the firm to discuss 2013 business climate issues.
- **OCIG meeting held** Met at JCI and had a tour of their facility.

- **Hosted Visit from Agracel** Toured the County and discussed potential.
- **Hosted Visit from JDA** Toured the County and discussed potential.
- **Hosted Visit from Cely** Discussed a developer built spec building in Oconee.
- **Hosted CBRE Industrial Brokers** Held a second meeting with this brokerage team.






