Oconee County is seeking quotations from qualified contractors to pour and finish two concrete pads located at the Solid Waste Complex, 15028 Wells Hwy, Seneca, SC, 29678. ### **Minimum Specifications**

The following minimum specifications shall apply:

- Pour and finish two concrete pads including setting of forms (framing or wire to be supplied by contractor if necessary),
- Broom finish
- Saw-cut expansion joints
- One pad will be approximately 135 feet X 25 feet X 6 inches deep (62.5 cubic yards)
- One pad will be approximately 100 feet X 25 feet X 6 inches deep (47 cubic yards)
- Work needs to be completed between August 1, 2018 and September 21, 2018
