## MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, June 16, 1987 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Harper.

Mr. Dyar made a motion, seconded by Mr. Butts, approved 5 - 0 that the minutes of the June 2, 1987 meeting be adopted as printed.

Mr. Crain presented Resolution 87-6, "A Resolution Honoring the Seneca "Bobcat" Baseball Team on Becoming the State AAA Champions" to the team and coach.

Mr. Thomas Alexander, Member of the House of Representatives, also presented a resolution to the team.

Next on the agenda was a public hearing to receive written and/or oral comments concerning the rental property at the airport.

There was no one present with written and/or oral comments for the public hearing.

Mr. Williams made a motion, seconded by Mr. Dyar, approved 5 - 0 that Joyce Elliott be awarded the bid for renting the brick house at \$350.00 per month and Mr. Mark Gettys be awarded the bid for the small house at \$40.00 per month.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the attached Mutual Aid Agreement between the Oconee County Sheriff's Department and the Pickens County Sheriff's Department be adopted.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the Sheriff also be allowed to negotiate a mutual aid agreement with the Anderson County Sheriff's Department.

At the request of Sheriff Earl Holcombe & Deputy Steve Pruitt, Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 that a donation account be set up for an emergency response team.

Mr. Frank Gibson of Southern Bell addressed Council concerning the E 911 system whereby in an emergency situation someone could reach the proper authorities by dialing 911. He stated that upon implementation of the program it will cost the phone subscriber \$.92 per month for the first twelve (12) months, the monthly rate then will go to \$.48 per month. Mr. Dyar made a motion, seconded by Dr. Earle, approved 5 - 0 that Oconee County enter into a contract with Southern Bell for this service subject to the contract being approved by the County Attorney.

Mr. Dyar requested a Roads & Transportation Committee Meeting, Wednesday, June 24, 1987 at  $4\!:\!00$  PM for an onsite inspection of the John Land Road.

Mr. Harper made a motion, seconded by Mr. Butts, approved 5 - 0 that Mr. Bruce Norton be appointed to the Library Board with his term commencing July 1, 1987 and expiring June 30, 1991.

Mr. Harper made a motion, seconded by Mr. Williams, approved 5 - 0 that the new contract for the Seneca Health Clinic be approved, the monthly rate will go from \$500 to \$600, also the climate control and the roof is to be repaired.

Dr. Earle made a motion, seconded by Mr. Williams, approved 5-0 that \$1,178.80 be taken from contingency and placed in line item number 10 019 00150 00056, Data Processing, for Cott Data Processing of deeds, mortgages and plats.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 that \$2,559.75 be taken from contingency and placed in line item number 10 023 00150 00026, Court Expense for forms mandated by the South Carolina Supreme Court.

Mr. Williams made a motion, seconded by Mr. Butts, approved 5 - 0 that the attached arts contract be approved.

The county budgeted \$6,200 to replace the roof at Lakeview Rest Home. The only bid was in the amount of \$7,362.70, negotiations with bidder to reduce the amount to the budgeted amount was unsuccessful. Therefore, Dr. Earle made a motion, seconded by Mr. Williams to dispense with the regular bid process and award the contract to a negotiated bid of \$5,345 to Campbell Brothers. This was approved 4-1 (Mr. Butts voting against). This is in keeping with Section II C (g) 4 of Oconee County's Manual of Centralized Purchasing, Ordinance 85-2.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 that Oconee County accept bids for a new chassis for a trash truck for the CCS Department.
