MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, July 7, 1987 at 7:00 PM in Council Chambers with all Council Members and the County Attorney present.

Members of the press notified (by mail): Seneca Journal, Keowee Courier, Greenville News, Anderson Independent, The Oconee Leader, WGOG Radio, WSNW Radio, WCCP Radio, WYFF TV & WLOS TV.

Members of the press present: Dave Partenheimer - WSNW Radio, Beth Lowery - The Seneca Journal & Randall Holcombe - The Greenville News.

The invocation was given by Mr. Dyar.

Mr. Dyar made a motion, seconded by Mr. Butts, approved 5 - 0 that the minutes of the June 16, 1987 meeting be adopted as printed.

Mr. Adam Rhomoshosky of Oconee Beautiful presented a resolution from the Association in appreciation for the steps taken by the Supervisor & County Council to curb litter in Oconee County.

At the request of the Blue Ridge Arts Association, Mr. Harper made a motion, seconded by Dr. Earle, the Oconee County waive its right to contest the sell of and waive its right of reverter concerning 2.25 acres of land in the Bountyland Community owned by the Association. After much discussion Mr. Harper amended his motion to include a quit claim deed from Oconee County to the purchaser of any interest in the property. Dr. Earle seconded the amendment and it was approved 5-0. The amended motion was adopted 4-1 (Mr. Williams voting against).

At the request of Mr. Bob Winchester, Sewer Commission Director, Dr. Earle made a motion, seconded by Mr. Dyar, approved 5 - 0 that the contract with O'Neal Engineering, Inc. in the amount of \$41,000 be adopted for Engineering/Design for the upgrading of the Perkins Creek Pump Station be approved.

Dr. Earle made a motion, seconded by Mr. Dyar, approved 5 - O Resolution 87-7, "A Resolution Congratulating Mr. Walter Purcell on Being Named Emergency Preparedness Director of the Year" be adopted on first and final reading.

Mr. Dyar made a motion, seconded by Mr. Williams, approved 5 - O that the attached data processing contracts for the Treasurer, Tax Collector & Tax Center be approved.

Mr. Williams made a motion, seconded by Mr. Dyar, approved 5 - 0 that Edwards Auto Sales be awarded the bid for a 1987 Ford F-350 Chassis for the CCS Department. This was the only bid received, the amount was \$11,800 including tax. (See attached bid sheet)

Mrs. Marianne Dillard, Purchasing Director, addressed Council concerning insurance for the county. After some discussion Dr. Earle made a motion, seconded by Mr. Dyar, approved 5 - 0 that as the county's insurance comes due that all the insurance be obtained through the state. This is in keeping with provisions of subsection (b) of Section 15-78-140 of the South Carolina State Code of Laws, 1976, as amended which requires all or none of our insurance be obtained through the state.

Mrs. Dillard also requested a committee meeting immediately prior to the next Council Meeting to discuss telephone service for the county.

Mr. Crain informed Council that Senator Alexander S. Macaulay wanted the Delegation, County Council and the School Board to meet together to discuss school financial problems. The majority of Council said August 5, 1987 at 7:30 PM would be the best time for them to meet.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 that \$15,005.18 be taken from contingency and placed in line item number 10 007 00150 00715 to pay workmen's compensation. These bills were late coming in.
