Mr. Timms made a motion that the bid for the roof for the Pine Street Administrative Offices be awarded to Zorn Construction. This motion died for lack of a second.

Mr. Thomas made a motion, seconded by Mr. Hall, approved 3 – 1 (Mrs. Hughes voting against) that the bid for the roof for the Pine Street Administrative Offices be awarded to Zorn Construction at a total cost of \$1,019,686, this is 5% higher than the bid received October 8, 1998, however the county had attempted to negotiate with the low bidder as the original bid exceeded the budget amount, the county had looked at other alternatives, but these were unsatisfactory and the work needs to be done as quickly as possible and Council felt it would be difficult to secure additional bids. The funds for this project were approved in the supplemental appropriation ordinance.

Mrs. Hughes was opposed to this action, as it was contrary to the advice given Council by the County Attorney.
