## MINUTES, SPECIAL MEETING, OCONEE COUNTY COUNCIL

The Oconce County Council held a special meeting Tuesday, August 22, 2000 at 2:30 PM in Council Chambers with all Council Members and the County Attorney present.

#### Call to Order:

# Recommendations of Purchasing, Contracting, Real Estate, Building & Grounds Committee (Contingency):

Mr. Thomas, Chair, Purchasing, Contracting, Real Estate, Building & Grounds Committee, informed Council it was the recommendation of the committee that up to \$25,000 be taken from contingency to implement the plan DHEC submits to the county to correct the problems with the septic system at Lakeview Rest Home and it be treated as an emergency purchase as delineated in Section II, Subsection D of Ordinance 85-2, "OCONEE COUNTY MANUAL OF CENTRALIZED PURCHASING". This recommendation was adopted unanimously.

Mr. Thomas further informed Council it was the recommendation of the Purchasing, Contracting, Real Estate, Building & Grounds Committee that the County Public Buildings Department take over the ground maintenance of the Walhalla & Seneca Health Clinics and that the Procurement Director be instructed to secure a plan (maybe using the Clemson Extension Service) for landscaping of the Seneca Health Clinic using some type low growing plants on the steep part of the bank to eliminate the cutting of the banks. Also, when all the construction invoices have been paid, put the remaining funds in line items. This recommendation was unanimously adopted.
