**Memorandum of Agreement
between the
Oconee County Council
and the
Coneross Waterfowl & Wildlife Planning Committee
for the
Organization, Planning and Development
of the
Coneross Waterfowl and Wildlife Refuge**

The Coneross Waterfowl & Wildlife Refuge is located on a 387 acre tract of land southwest of Walhalla owned by Oconee County and located near the city limits. The property includes a 57-acre lake formally known as the Coneross Reservoir, which has served as a watershed for the City of Walhalla for over 30 years. Historically, the property has also been commonly known as "the Poor Farm property."

Project Definition

On March 17, 1987 the Oconee County Council designated, by official county ordinance 87-2 this real property as a waterfowl and wildlife sanctuary (see document attached). Pursuant to this action a citizen advisory committee was formed to plan, organize, guide and implement a general management plan for the site. (See attached list of the board of directors and other current members of the official citizen planning committee.)

This agreement reaffirms the advisory role of the Coneross Waterfowl & Wildlife Refuge planning committee to work with county, state and federal agencies to create a high quality waterfowl/wildlife refuge following modern conservation practices. The ultimate goal is to provide outdoor recreational opportunities to the citizens of Oconee County, as well as to create educational opportunities for local schoolchildren and adults in the areas of sound conservation practices, land restoration, wildlife management and related environmental issues.

Mission Statement

The C.W.W.R. planning committee hereby commits to work within the parameters of its official mission statement: "The mission of the Coneross Waterfowl and Wildlife Refuge is to create and maintain a quality habitat for wildlife while providing in-depth experiences for adults and children through educational programming designed to: 1) nurture an understanding of the importance of sound conservation practices, 2) encourage an appreciation for the environment and, 3) encourage responsible stewardship of the earth's natural resources."

The C.W.W.R. planning committee agrees to undertake the following measures:

1. To seek out and build the necessary partnerships within the community, state, region and on a national level, to accomplish the goals and objectives set forth by the planning committee.
2. To seek out appropriate funding sources through foundations and grants to assist with the cost of resources necessary for the planning, development and completion of the project. This includes the creation of a master plan for a formal fundraising campaign. This will not preclude the county from mounting funds or grants to achieve the mutual goals of the county and the C.W.W.R.
3. To create a long range conservation and land management plan with the help of the Natural Resource Conservation Service, S.C. Forestry Commission and Clemson University Cooperative Extension Service and then working closely with those entities in the county which are best suited for implementation of the long range management plan.
4. To work closely with representatives of the School District of Oconee County to design an educational component which will dovetail and strongly support current South Carolina curriculum requirements.

Implementation

WHEREAS, the C.W.W.R. planning committee shall enter into NO legal contracts, make no commitments to spend county funds and shall not accrue debts without the approval of the Oconee County Council, the planning committee does have the approval of the Oconee County Council to seek donations of resources, services and materials necessary for the completion of the project. The planning committee shall have no fiduciary responsibility, but is sanctioned to represent the county in partnerships formed to accomplish long-range goals for the project; and

WHEREAS, Oconee County retains full ownership and responsibility for the real property now known as the Coneross Waterfowl & Wildlife Refuge, in order to enter into binding agreements and represent the County in negotiations to acquire materials, services, financial and other resources, the C.W.W.R. planning committee is hereby granted a temporary empowerment for a period not to exceed two years or twenty-four months, which term may be extended in ten (10) year intervals upon satisfactory performance of the initial term.

The parties hereby execute this agreement by their duly authorized representatives' signatures on the dates indicated below.

OCONEE COUNTY COUNCIL

ORDINANCE 87-2

AN ORDINANCE TO RESTRICT THE USE OF REAL PROPERTY OWNED BY OCONEE COUNTY, SOUTH CAROLINA COMMONLY KNOWN AS "THE POOR FARM" BY MAKING A PORTION THEREOF A WATERFOWL SANCTUARY WHERE HUNTING OF ANYKIND IS ABSOLUTELY PROHIBITED AND MAKING THE DISCHARGE OF RIFLES ON THE WHOLE OF THE PROPERTY UNLAWFUL AND TO PROVIDE PENALTIES FOR ANYONE FOUND VIOLATING THE PROVISIONS HEREOF

BE IT ORDAINED by Oconee County Council, in Session duly assembled, upon approval by a majority of Council upon Third Reading as follows:

SECTION 1:

(a) The portion of the watershed lake located on property owned by Oconee County, adjacent to Hunter's Run Subdivision and near the Lakewood Rest Home in the area on the eastern side of the lake extending to a dirt road presently existing, is hereby designated as a waterfowl sanctuary or preserve.

(b) The portion of property owned by Oconee County, adjacent to the waterfowl sanctuary or preserve described in (a) above and lying north of County Road TU 7, that is presently in pasture and contains approximately 41.50 acres, is hereby designated as an all-game preserve or sanctuary.

(c) The entire portion of property owned by Oconee County, lying north of County Road Number TU 7, is hereby declared to be restricted from the discharge of rifles.

SECTION 2:

(a) It shall be unlawful for any person to hunt, snare, trap and/or kill wild game, particularly waterfowl, on, in or over the areas designated as a waterfowl sanctuary or preserve pursuant to Section 1(a) and/or the area designated as an all-game preserve or sanctuary pursuant to Section 1(b).

(b) It shall be unlawful for any person to discharge a rifle or rifles on, in or over the entire portion of property owned by Oconee County designated in 1(c) above.

(c) Nothing contained herein shall be construed to prohibit fishing, swimming or boating in the watershed lake.

III. NARRATIVE PROJECT DESCRIPTION

- A. Project Title - Mountain Spirit of the River festival
- B. Description of project: This will be the inaugural festival for the Mountain Spirit of the River in the Upcountry region of South Carolina. A Spirit of the River event has been held in the Lowcountry of South Carolina for the past few years that is sponsored by the SC Paddlesports Association, SC State Parks Service, and several other partner organizations. The Upcountry event will be held on May 15, 2004 in Long Creek. The centerpiece of this event will be the celebration of the 30th anniversary of the Chattooga River's designation by Congress as a National Wild and Scenic River. A representative from the US Forest Service will be in attendance at the event to commemorate this occasion and dedicate a permanent marker at the Bull Slator area launch site. Several other dignitaries and elected officials will be in attendance at this event.

The festival also includes a full day of activities that will celebrate the many outdoor recreation opportunities available in the Chattooga River Corridor and the Andrew Pickens District of the Sumter National Forest. Below is a tentative schedule of events:

A sample of seminar topics is history of the Chattooga River, outdoor photography techniques, conservation and preservation of natural resources, and fly fishing lessons.

The festival is a partnership between several groups who are all committed to both stewardship of the natural resources and responsible recreation and tourism use of these resources. Partners include the US Forest Service, the SC Paddlesports Association, American Whitewater, Trout Unlimited, Footbills Trail Conference, and Discover Upcountry Carolina Association.

The intent by the organizing partners is for this event to become an annual event and to expand its activities in forthcoming years.

- C. Who will benefit from this project? The goal of the Mountain Spirit of the River is to gain exposure for the numerous outdoor recreational opportunities available in the Chattooga River corridor and the Andrew Pickens District of the Sumter National Forest. Advertising and marketing efforts will target individuals and groups within all of South Carolina and in North Carolina and Georgia within a 100-mile radius of Oconee County. The promotional brochure that will be used to publicize this event will include a variety of information about Oconee County's attractions, points of interest, and lodging properties. It is the intent of the organizers and sponsors that this event will be not only a benefit to the area on the weekend of the festival, but will be a catalyst to promote the area's tourism and recreation opportunities throughout the year.

VI. DEMOGRAPHIC DATA

How will the project influence tourism in Oconee County? The event will benefit Oconee County's tourism industry both during the weekend of the festival and throughout the year. Through the marketing and public relations efforts of all of the partners and sponsors of this event, attention to the area's attractions, recreation opportunities, culture, attractions and special events will be realized. On the event website, links will be provided to Oconee County chambers of commerce and lodging properties.

How many visitors/participants attended the event last year and are anticipated this year? This is a new event and therefore doesn't have a history to pull from. It is anticipated that the event itself will draw around 200 attendees, however the goal is to leverage exposure to the area that will attract visitors throughout the year.

How many of the visitors/participants were from beyond a 50-mile radius of Oconee County last year and are anticipated this year? An estimated 150, or 74% of the attendees are expected to be from more than 50 miles from the county.

How many overnight stays were created by this event last year and are anticipated this year? Again, as the event is in its inaugural year, no historical data is available. The estimated room nights generated for this year in Oconee County is 125.

How do you plan to advertise this event beyond a 50-mile radius of Oconee County? The brochures and posters that will be produced for the event will be distributed to outfitting stores, outdoor tour operators, fishing shops, sports and fitness stores, as well as regional clubs and organizations in and around Atlanta GA, Charlotte, NC, Asheville, NC, Columbia SC, Greenville SC, Charleston SC, Jacksonville FL, Orlando FL, Tampa FL, etc. using current relationships with these outlets.

In addition to, information will also be placed on several websites - including those of Discover Upcountry Carolina Association, the SC Paddlesports Association, and the US Forest Service. Other partners such as the Foothills Trail Conference and Trout Unlimited will disseminate the information through newsletters and e-mail listservs.

Press releases will be developed and distributed to media outlets throughout South Carolina and in the 100-mile radius of Oconee County. These releases will be sent primarily by the US Forest Service, but also from other partner organizations.

What other documentation can you provide demonstrating this event promotes tourism in Oconee County? (i.e. photographs, letters from local chambers of commerce, restaurants, shop or accommodations owners) Press releases, news clippings and website postings will be provided to demonstrate the marketing efforts for the event. Lodging and campground properties will also be surveyed to determine the amount of benefit to their establishments.

What records will be kept during this event to obtain the above demographic data? (i.e. guest logs, phone logs, accommodations contracts, website hits, advertising demographics) The participants in the festival will provide information to us regarding their demographics as well as how they learned about the event. Website hits from the event website will be provided. Press clippings from newspapers, newsletters, etc. will be gathered to determine the amount of exposure received. From the survey of lodging and campground properties, we will also be able to determine the economic impact of the overnight visitors to the festival.

OCONEE COUNTY COUNCIL ORDINANCE NO. 2004-

AN ORDINANCE TO AMEND OCONEE COUNTY ORDINANCE 2002-15, AN ORDINANCE REGULATING THE USE OF ALL OF OCONEE COUNTY PARKS AND RECREATION AREAS.

BE IT ORDAINED, by the Oconee County Council, in session, duly assembled and with a quorum present and voting that Ordinance 2002-15, which adopted regulations for the use of all of Oconee County public parks and recreation areas is hereby amended as follows.

The following section shall be added to Ordinance 2002-15:

(F)(7) Golf carts may be operated at all Oconee County Public Parks and Recreation Areas subject to the following regulations.

(a) All carts must have a valid registration with the Department of Motor Vehicles, display the Department of Motor Vehicles' sticker at all times, and carry proof of insurance.

(b) Golf carts shall only be driven by people with a valid driver's license who are named insured on the golf cart's insurance policy.

(c) Golf carts shall only be driven on park roads.

(d) Golf carts shall only be driven from one park facility to another.

(e) Golf carts shall not be used to cruise the park grounds.

(f) Golf carts with headlights and taillights shall only be driven from sunrise until sunset.

(g) Golf carts with headlights and taillights shall not be driven between the hours of 10:00 p.m. and 7:00 a.m.

RE: Oconee County Courthouse - Recommended Noise Controls

Dear Messrs. Clark and Van Bergen:

We have reviewed the correspondence between you and Heery International regarding the recommendations by Egan Acoustics. In a recent letter to the County from Michael O'Brien of Heery, he felt like there were still some unknowns in Mr. Egan's recommendations that had not been addressed. I spoke with Clint Fairchild and Mike Tomy yesterday and stated to them that the County would like to proceed with letting you try some of the recommended noise abatement strategies, even though they may still have some reservations. It has been one year now and we must quit studying and writing about the problem, and start doing something! They recommended that before authorizing you to proceed, you provide us with the following information:

A detailed outline of exactly what you are recommending, to include a sequence of events, and estimated time to complete. It is imperative that we minimize the impact and disruption to court activities in the building. Also, we would like to know exactly who would be performing what phases of the work.

Let me emphasize that if we allow you to implement your proposed noise control measures and they do not achieve the goal of NC30, we will expect you to continue to work on a solution that will indeed achieve that goal, as that is what your consultant says is acceptable.

With regard to the ADA issues, Ron your e-mail of April 23rd indicated that the UFAS report was to be complete and a copy sent to us last week. I have not seen that report yet, nor heard anything else from Fran Trapp's office. Please let me know immediately the status of that issue. I look forward to hearing from you soon.

The second proposal was from CDAI for courtroom audio systems investigation in the amount of \$2,300.

I have spoken with Mr. Fairchild and Mr. Tomy and they have indicated that the product we would have from the conceptual design would be something that Mr. Clark could then take and complete the design for construction. Additionally, the proposal from CDAI would give us some cost estimates to upgrade the systems to an acceptable level. Remember that the sound system was a separate contract, and any cost of changes will have to be borne by the County.

I would strongly recommend that we proceed with issuing purchase orders for those two projects, as I do not foresee them interfering with any recommendations that might be forthcoming from the DOJ. (Of course the final sound system modifications would not take place until the changes are made in the courtrooms.)

Sally Lowery's balance sheet for the courthouse shows a balance of \$125,435 as of 4/13/04. I would recommend that we take the money from this balance for those projects.

Please let me know if you wish me to proceed with this matter.

We appreciate the opportunity to offer our services for this project. Our understanding is that our initial scope of work would be to inspect the existing courtroom audio systems and to subsequently prepare a report summarizing our findings and providing recommendations. There are five courtrooms to be included in the scope: two smaller Family Courts, two Circuit Courts and one Main Courtroom. We see the effort to accomplish this initial work as follows:

- Specialty Contract
- Project
- Design
- Construction
- Trade

1. Review existing documentation and reports relating to the courtrooms including the available Contract Documents and the October 27, 2003, Investigation Report prepared by Heery International, Inc.
2. Make one site visit to investigate and document the existing courtroom audio systems and related room elements. While we understand that the courtrooms may be substantially revised, it is important to have sufficient understanding of the existing conditions in order to obtain information on the existing audio systems, to analyze the identified concerns or issues, and to develop possible remedial system recommendations.
3. Prepare a written report summarizing the findings of the site investigation and documenting identified discrepancies or issues.
4. As part of the Site Investigation Report, prepare a written summary of recommended additions, revisions or remedial treatments to the audio systems. CDAI will attempt to present multiple alternatives either as a base system with add alternates or as multiple "levels" of systems' capability.
