MINUTES, OCONEE COUNTY COUNCIL MEETING

The Oconee County Council met Tuesday, June 20, 2006 at 7:00 pm in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members except Mr. Moore present.

Chairman Ables called the meeting to order.

Invocation:

Mr. Rinehart gave the invocation.

Pledge of Allegiance:

Mr. Lyles led the pledge of allegiance to the US Flag.

Minutes:

Mr. Lyles made a motion, seconded by Mr. Crumpton, approved 3-0 that the minutes of the regular meeting held June 6, 2006 be adopted as printed.

Public Comment Session:

Mr. Al Tossie addressed Council regarding reassessment of properties in Oconee County.

Public Comment Session Continued:

Mr. Berry Nichols addressed Council regarding citizens having a two way conversation with Council and the Delegation.

Mr. Tom Markovich addressed Council regarding proposed Ordinance 2006-20, "AN ORDINANCE AMENDING CHAPTER 6 OF ORDINANCE 99-14, PERFORMANCE STANDARDS ORDINANCE WITH THE REQUIREMENTS CONTAINED IN CHAPTER 7 AND ABOLISHING CHAPTER 7".

Mr. George Blanchard addressed Council regarding proposed Ordinance 2006-19, "AN ORDINANCE FORMALLY ADOPTING VALUES ESTABLISHED BY THE COUNTY ASSESSOR AND SOUTH CAROLINA DEPARTMENT OF REVENUE BASED ON A DECEMBER 31, 2005 VALUATION DATE FOR TAX YEAR 2006". Mr. Blanchard also addressed Council regarding the delaying of reassessment of properties in Oconee County.

Mr. Jim Doyle addressed Council requesting a delay of reassessment on properties in Oconee County.

Ordinance 2006-13:

Mr. Crumpton made a motion, seconded by Mr. Lyles, approved 4 – 0 that Ordinance 2006-13, "AN ORDINANCE AMENDING ORDINANCE 2003-12 WHICH ESTABLISHED THE KEOWEE FIRE TAX DISTRICT AND THE KEOWEE FIRE COMMISSION" be adopted on third and final reading.

Ordinance 2005-15:

Mr. Crumpton made a motion, seconded by Mr. Lyles, approved 3-1 (Mr. Rinehart voting against) that Ordinance 2006-15, "THE 2006-2007 BUDGET APPROPRIATIONS ORDINANCE FOR OCONEE COUNTY" be adopted on third and final reading. However, adoption of the ordinance failed as it requires a super-majority vote in the affirmative to become effective.

Homestead Exemption:

Mr. Crumpton then made a motion, seconded by Mr. Lyles, approved 4 – 0 that the County Attorney write the Legislative Delegation a letter on behalf of Council requesting that the homestead exemption be raised from \$50,000 to \$100,000 with a guaranteed annual escalation factor to cover inflation, and also adjusted upward anytime the county implements reassessment.

Ordinance 2006-16:

Mr. Lyles made a motion, seconded by Mr. Rinehart, approved 4 – 0 that Ordinance 2006-16, "THE 2006-2007 BUDGET APPROPRIATIONS ORDINANCE FOR THE SCHOOL DISTRICT OF OCONEE COUNTY AND TRI COUNTY TECHNICAL COLLEGE" be adopted on third and final reading.

Ordinance 2006-19:

Mr. Lyles made a motion, seconded by Mr. Crumpton, approved 4 – 0 that Ordinance 2006-19, "AN ORDINANCE FORMALLY ADOPTING VALUES ESTABLISHED BY THE COUNTY ASSESSOR AND SOUTH CAROLINA DEPARTMENT OF REVENUE BASED ON A DECEMBER 31, 2005 VALUATION DATE FOR TAX YEAR 2006" be adopted on second reading.

Ordinance 2006-20:

Mr. Rinehart made a motion, seconded by Mr. Crumpton, approved 4-0 that Ordinance 2006-20, "AN ORDINANCE AMENDING CHAPTER 6 OF ORDINANCE 99-14, PERFORMANCE STANDARDS ORDINANCE WITH THE REQUIREMENTS CONTAINED IN CHAPTER 7 & ABOLISHING CHAPTER 7" be adopted on first reading.

Solid Waste:

Mr. Crumpton made a motion, seconded by Mr. Lyles, approved 4-0 that the bid for a wheel loader for Solid Waste be awarded to Linder Industrial Machinery Co., who was low bid at \$100,542. (See attached bid sheet)
