## **Discussion Regarding Action Items**

#### Oconee County Proposed Millage for Tax Year 2013

Millage approval required to fund FY 2014 for 1) Oconee County and The School District of Oconee County operational budgets to include Tri-County Tec and other such special projects such as Economic Development and Bridges and Culverts 2) and bond payments for the County and SDOC 3) Keowee Fire District Millage.

Millage is set in September to provide tax calculations for timely processing of tax notices beginning in October as set forth by the SC Department of Revenue. Additional information will be presented at the meeting from the Auditor, Mr, Ken Nix.

#### Roads & Bridges Various Equipment / \$681,601.00

Approval is requested for the following equipment for the Roads & Bridges department to be purchased from Blanchard Machinery in Simpsonville, SC: Caterpillar Hydraulic Excavator, 329E / \$284,201; Caterpillar Mini Hydraulic Excavator / \$115,696; LeeBoy 8616 Asphalt Paving Machine / \$202,975; LeeBoy 420 Pneumatic Roller / \$47,141; Road Widener Skid Steer Attachments / \$31,588.00

These purchases are all contingent on the approval of the lease/purchase funding, authorized in the 2013-2014 budget allocations.

The National Joint Powers Alliance is a national purchasing cooperative that Oconee County Procurement recently joined. It makes contracts available to its members that are bid on the national level and then fulfilled by local or state dealers.

It is the staff's recommendation that Council approve the purchases of the equipment as listed on the Agenda Item Summary from Blanchard Machinery of Simpsonville, SC in the total amount of \$681,601.

#### Multiple Ford Vehicles / Multiple Departments / \$275,665.00

Approval is requested for the following Ford vehicles to be purchased from the State Contract awarded vendor, Vic Bailey Ford, of Spartanburg, SC. All of these vehicles were approved in the 2013-2014 budget as replacement vehicles: Animal Control / F-150 Truck; Sheriff / F-150 Truck; Sheriff / F-150, Super Crew Cab, 4x4; Assessor's Office / Escape 4x4; Vehicle Maintenance / (2) F-250 3/4 ton Cab & Chassis with utility bed; Emergency Services / (5) F-250, Crew Cab, 4x4

These purchases are all contingent on the approval of the lease/purchase funding, authorized in the 2013-2014 budget allocations with the exception of one Ford F-150 for Animal Control that is not lease purchase.

It is the staff's recommendation that Council approve the purchases of these Ford vehicles as listed on the Agenda Item Summary to Vic Bailey Ford, of Spartanburg, SC, in the amount of \$275,665.00, per State Contracts # 4400005808, 4400005812, 4400004309 and 4400004337.
