## OCONEE COUNTY COUNCIL MEETING Regular Meeting March 17, 2015

Mr. B. J. Littleton addressed Council in support for the projects on the capital project sales tax referendum but felt that bond funding was the reason for the referendum's defeat.

Mr. Cain made a motion, seconded by Mr. Dexter, approved 5-0 to approve **Proclamation P2015-03** on first & final reading. Mr. McCall presented the Proclamation to Ms. Moss commending her on a job well done.

## **Public Hearings regarding the Following Ordinances**

Ordinance 2015-09 "AN ORDINANCE AMENDING SECTION 12-34 OF ARTICLE II OF CHAPTER 12 OF THE OCONEE COUNTY CODE OF ORDINANCES, IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, REGARDING NOISE REGULATIONS OF THE COUNTY; AND OTHER MATTERS RELATED THERETO"

Mr. McCall opened the floor for Public Comment.

Mr. Gary Littlefield addressed Council in opposition to passage of Ordinance 2015-09 expressing concerns that there are not objective standards in the ordinance for enforcement.

Ms. Susie Cornelius addressed Council in opposition to passage of Ordinance 2015-09 and other matters not related specifically to this ordinance.

Mr. Ben Turetzky addressed Council in support for passage of Ordinance 2015-09; noting that there are enforcement issues as written.

Mr. McCall asked if any other citizens wished to address Council.

Mr. Ryan Honea addressed Council in support for passage of Ordinance 2015-09.

Mr. Don Leslie addressed Council in support for passage of Ordinance 2015-09.

Mr. McCall asked if any citizens wished to submit written comments regarding this ordinance; no citizen presented any written comments for the record.

Mr. McCall closed the Public Hearing regarding **Ordinance 2015-09**.

## Third & Final Reading of the Following Ordinances

**Ordinance 2015-09** "AN ORDINANCE AMENDING SECTION 12-34 OF ARTICLE II OF CHAPTER 12 OF THE OCONEE COUNTY CODE OF ORDINANCES, IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, REGARDING NOISE REGULATIONS OF THE COUNTY; AND OTHER MATTERS RELATED THERETO"

Mr. Dexter made a motion, seconded by Mr. Cain, to approve **Ordinance 2015-09** on third & final reading. Discussion followed regarding deferring third reading to allow for language revision, federal decibel guidelines, and adopting the ordinance at this meeting but continuing to review and update language for inclusion of objective measurements.

Mr. McCall called for the vote. The motion passed 4 - 1 [Ms. Cammick opposed] to approve **Ordinance 2015-09** on third and final reading.

### **Second Reading of the Following Ordinances**

Ordinance 2015-12 "AN ORDINANCE TO REVISE AND AMEND SECTION 34-1 OF THE OCONEE COUNTY CODE OF ORDINANCES, BY DELETING AND RESCINDING THE SECTION IN ITS ENTIRETY; AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve **Ordinance 2015-12** on second reading.

#### First & Final Reading of the Following Resolutions

**Resolution 2015-05** "A RESOLUTION TO APPROVE LAW ENFORCEMENT ASSISTANCE AND SUPPORT AGREEMENT BETWEEN OCONEE COUNTY SHERIFF'S OFFICE AND DARLINGTON COUNTY SHERIFF'S OFFICE" including Law Enforcement Assistance & Support Agreement

**Resolution 2015-06** "A RESOLUTION TO APPROVE LAW ENFORCEMENT ASSISTANCE AND SUPPORT AGREEMENT BETWEEN OCONEE COUNTY SHERIFF'S OFFICE AND FLORENCE COUNTY SHERIFF'S OFFICE" including Law Enforcement Assistance & Support Agreement

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5-0 to approve both **Resolution R2015-05** and **Resolution 2015-06** on first & final reading.

Ms. Cammick made a motion, seconded by Mr. Thrift, approved 5-0 to adopt the Mission Statement as follows:

"It is the mission of Oconee County to provide our current and future citizens and visitors quality services while protecting our communities, heritage, environment and natural resources, in an ever-changing world."
