## Call to Order:

Ms. Hulse, staff liaison, called the meeting to order at 6:00 p.m. prior to election of officers.

## **Election of Officers:**

#### Chairman:

Mr. Airey and Mr. Hill both stated their willingness to serve as officers for the Board.

Mr. Lee made a motion, seconded by Mr. Hill, nominating Mr. Airey as Chair of the Oconee County Conservation Bank Board for a one year term. No other nominations were received from the floor. Ms. Hulse called for the vote. Mr. Airey was cleated 6 – 0 – 1 [Mr. Airey abstained].

Mr. Airey conducted the remainder of the meeting.

#### Vice Chairman:

Mr. Aircy made a motion, seconded by Mr. Prater, nominating Mr. Hill as Vice Chair of the Oconee County Conservation Bank Board for a one year term. No other nominations were received from the floor. Mr. Airey called for the vote. Mr. Hill was elected 6 – 0 – I [Mr. Hill abstained].

#### Secretary:

Mr. Airey made a motion, seconded by Mr. Hill, nominating Mr. Nation as Secretary of the Oconce County Conscrivation Bank Board for a one year term. No other nominations were received form the floor. Mr. Airey called for the vote. Mr. Nation was elected 6 - 0 - 1 [Mr. Nation abstained].

Mr. Aircy asked Ms. Hulse to prepare the minutes from this meeting to assist Mr. Nation. In addition, he requested that she continue to attend meetings of the group as the county's liaison until such time as she is not needed. Ms. Hulse agreed to prepare the minutes and assist the board in any way needed.
