- 1. Call to Order Mr. Johnson called the meeting to order at 6:02 PM.
- 2. Invocation was led by Mr. Nix
- 3. Pledge of Allegiance was led by Mrs. Spicer
- 4. Approval of minutes from February 22, 2024 Mr. Owens made a motion to approve the minutes; Seconded by Mr. Adams. Approved unanimously.
 - Mr. Johnson made a motion to move the discussion regarding Planning Commission Goals and Objectives for 2024 to a future meeting; Seconded by Mr. Gaulin. Approved Unanimously.
